Private Practice Nurses asked to Contribute to Nursing Research

There is still an opportunity for members to participate in a research study into nursing regulation and the licensing of nurses in unique and non-traditional practices conducted by Sarah Wall, a nurse researcher from the University of Alberta.

There is little research into private practice nursing. Dr. Wall is interested in studying the impact of nursing professional regulation in Alberta. She would like to hear from nurses in unique practice situations about their interactions with the regulator to determine whether regulatory practices constrain non-traditional nurses' abilities to be licensed.
