### **BILLING POLICIES**

- ◆ **Landowner** is ultimately responsible for water service to his/her property.
- ◆ **Due Date** is the 15th of the each month.
- ◆ **\$10.00 Late Charge** will be applied if payment is not received twenty(20) days after billing and a reminder is sent.
- ◆ **Shut Off Notices** are issued 48 hours in advance, if payment is not received 30 days after the original billing date.
- ◆ **\$25.00 Shut Off Fee** is applied when shut off notices are issued.
- ◆ **\$75.00 Reconnection Fee** will be charged, to restore delinquent services upon payment in full. (\$100 after hours)

### **PAYMENT OPTIONS**

- ◆ **Cash, check, debit/credit cards & money orders** can be received in the District Office.
- ◆ **Payment Drop Box** at the District Office is accessible 24/7.
