Payment (Private Services):

- a. Payment is due at the time services are rendered. Payment may be made by personal check or cash. The "Company" can also provide a claim to the "Customer" for reimbursement with their payer source.
- b. A "late fee" of \$25.00 (in addition to the fees for services rendered) will be charged for payment not received on the day of services.
- c. A services fee of \$25.00 will be charged for reschedules/cancellation of visit less than 24 hours from the originally scheduled visit(s).
- d. If therapy is to be rescheduled/cancelled, the "customer" must call or email the "company" prior to 24 hours from scheduled visit.

Waiver of Liability:
