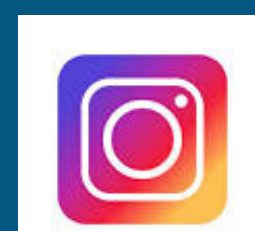

Q. 1. WHAT DO WE TEACH?

Q. 2. WHO ARE OUR TEACHERS?

ANS: YOU WILL BE PROVIDED HARD COPY OF THE SUMMARIES OF SC JUDGMENTS PREPARED BY OUR TEAM ON A WEEKLY BASIS. IMPORTANT RECENT JUDGMENTS WILL BE DISCUSSED BY RAJESH SIR HIMSELF.

Q. 4. CAN ONE TAKE SUBJECT WISE CLASSES?

ANS: YES. BUT THAT WOULD BE TOO EXPENSIVE. IT IS 5000 PER SUBJECT (FLAT CHARGE)

Q. 5. CAN FEES BE PAID IN INSTALLMENTS?

ANS: MAX TWO INSTALLMENTS. ONLY ONE MONTH GAP IS ALLOWED BETWEEN TWO INSTALLMENTS.

Q. 6. WILL MATERIAL BE PROVIDED?

ANS: YES. FOR ONLINE STUDENTS MATERIALS WILL BE SENT TO THEIR RESPECTIVE ADDRESSES (CHARGE RS. 3500/). SOFT COPY OF JUDGMENTS WILL BE PROVIDED. DICTATION WILL BE GIVEN ONLINE. YOU WILL HAVE THE FEEL OF OFFLINE CLASS.

Q. 7. WHETHER TESTS WILL BE CONDUCTED?

ANS: YES. ON COMPLETION OF THE COURSE OF EACH SUBJECT TWO TESTS WILL BE CONDUCTED: ONE OBJECTIVE AND ONE SUBJECTIVE. AFTER THE WHOLE COURSE WE WILL CONDUCT 5 TESTS FOR EACH BATCH. AFTER THAT STUDENTS CAN JOIN OUR TEST SERIES (STATE WISE) ON PAYMENT OF ADDITIONAL FEES FOR THE REST SERIES. WE USUALLY ANNOUNCE TEST SERIES BEFORE NOTIFICATION BY THE STATES. EACH TEST SERIES IS CUSTOMISED STATE WISE. PAPERS WILL BE EXAMINED BY OUR TEACHERS. EVERY TEST WILL BE FOLLOWED BY A SESSION IN WHICH ANSWERS WILL BE EXPLAINED.

Q. 8. WHETHER ONLINE STUDENTS CAN JOIN OFFLINE CLASSES?

ANS: YES. THEY WILL HAVE TO PAY THE DIFFERENCE.
