

# SafeAuto Official Rules

## OFFICIAL RULES SafeAuto Promotion (Uber Gift Card)

ELIGIBILITY: The SafeAuto promotion (the “Promotion”), is open to legal residents of the United States who are 18 years of age and older (potential “Entrant(s)”. Void in Puerto Rico and where prohibited. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members (whether related or not), of SafeAuto (“Sponsor”) its affiliates, subsidiaries, and divisions advertising and promotion agencies and prize partners are not eligible to enter. The promotion is subject to all applicable federal, state, and local laws. US law governs this promotion. Notwithstanding anything to the contrary, the promotion is void where prohibited. There is no purchase requirement to enter the promotion. Purchases do not improve the chances of winning.

The closing date for the final week is 11.59am on September 2<sup>nd</sup>, 2021 (the “End Date”).

2. MAIN METHOD(S) OF ENTRY: An entry (“Entry” or “Entries”) will be completed once an Entrant “follows” the SafeAuto IG Account & “likes” the specified post each week & “shares” on their IG channel(IG or Stories). Once this information has been submitted, an Entrant will receive a \$25 Uber Gift Card within ten (10) days. Entries will be deemed made by the authorized Instagram account holder used to submit at time of entry. The "authorized account holder" is deemed to be the natural person who is assigned to a particular Instagram account. A potential winner may be requested to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry. Limit one (1) entry per person and per e-mail address. More than one (1) entry from any one person or from any e-mail address will void all entries from that person or e-mail address, as applicable. 4. PRIZE. The Prize is a \$25 Uber gift card and is valued at \$25.00 US dollars. The Prize can be redeemed only on Uber accounts and cannot be redeemed against Uber Eats accounts. The winners must enter the Uber gift card PIN in their personal Uber accounts to redeem the credit. The Prize is non-transferable and non-refundable. No cash alternative is available for the Prize. All taxes and any other costs not specifically stated within these Official Rules are the sole responsibility of the winner. Prize may not be transferred, substituted, or redeemed for cash, except at the Sponsor's sole discretion.
