

**ABERDEEN AQUA ADDICTS WATER SKI TEAM WAIVER OF LIABILITY,  
INDEMNIFICATION, PR RELEASE AND MEDICAL RELEASE**

**On behalf of myself, and any minor participant designated below, I make the following acknowledgements and representations:**

I acknowledge that water skiing, and participating in acrobatic activities while water skiing, and using ski jumps, involve dangerous risks. Floating debris, underwater obstacles, falling at high speed, entanglement in equipment, collisions with other skiers, collisions with boats and equipment, and drowning are examples of some of the risks associated with water skiing and participating in acrobatic activities while water skiing. Understanding such risks, I will be voluntarily participating in the water skiing activities (practices, shows, demonstrations, competitions, and recreational skiing) organized by the Aberdeen Aqua Addicts Water Ski Team (Team), and I assume all risks, known and unknown, which may be associated with those water skiing activities. For myself, my heirs, administrators, and assigns, I hold the Team, its directors, officers, members, volunteers, agents, and assigns, harmless from any claims, of any type or nature, which I or my heirs and successors may have, resulting directly or indirectly; from participation in water skiing activities and events organized by, and associated with, the Team. For myself, my heirs, administrators, and assigns, I release and discharge the Team, its directors, officers, members, volunteers, agents and assigns from any liability for any claims for injury, death, and property damage resulting directly or indirectly, from participation in water skiing activities and events organized by, and associated with, the Team. The assumption of risk, indemnification, and release obligations accepted by me include volunteers, and others, who construct facilities, and manufacture equipment, used in the water skiing activities and events organized by, and associated with, the Team; my assumption of risk, indemnification and release obligations do not apply to for profit businesses that regularly construct such facilities and manufacture such equipment.

I consent to and authorize any assistance, first aid and medical treatment provided to me, and to any designated minor participant, in the event of any injury or illness during any water skiing activity or event organized by, or associated with, the Team.

I also authorize the Team to use my image, or the minor's image, in any media or format, for advertising, promotional and informational purposes, of any nature.

I have read and understand the Team Member Handbook and I agree that it is the responsibility of me and the minor participant to comply with all policies and procedures.

I HAVE READ THIS RELEASE AND I FULLY UNDERSTAND ITS PROVISIONS. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS FOR MYSELF AND THE MINOR PARTICIPANT BY SIGNING THIS RELEASE. I HAVE SIGNED THIS RELEASE FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTY BEING MADE TO ME. I INTEND THIS RELEASE TO BE, AND IT IS, A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. THIS RELEASE IS A CONTINUING ONE AND REMAINS IN FULL FORCE AND EFFECT WHENEVER I, OR MY MINOR PARTICIPATE IN ANY WATER SKIING ACTIVITY AND EVENT ORGANIZED BY, OR ASSOCIATED WITH, THE TEAM.
