On Sunday, 04/10/16, at approximately 0921 hrs, I (Ofc. T. Clark), responded to 629 Simonton St, to back Ofc. D. Hall (see crash report), in reference to a hit and run that had just occurred.

Prior to arrival, KWPD Dispatch advised a possible DUI driver and a passenger in a BMW had just hit multiple cars and fled the scene. Moments later KWPD Dispatch advised the suspect BMW was crashed with blown out tires at Simonton St and Southard St.

On arrival, I activated my body worn camera.

I saw a dark grey BMW (FL tag DNWV24), was partially on the sidewalk facing North in front of 629 Simonton St. The vehicle was severely damaged with front tires blown out and smashed in front.

I saw a Hispanic male, later identified as Alejandro Martinez-campos 01/08/84 (identified by FL DL), on the sidewalk. A Hispanic female, later identified as Melinda Cabrera 07/13/83 (identified by FL DL) was sitting inside the vehicle. Melinda clearly had been injured in the crash and had lacerations and bruising on her face. She refused rescue. KWFD and EMS responded to treat Melinda's injuries.

Alejandro and Melinda both told me that Alejandro was driving. There were numerous passersby and witness on the block. Ofc. D. Hall advised a positive ID, by several witnesses as Alejandro being the driver at the time of the crash and fleeing the scene with a witness.

Alejandro exhibited slurred speech, glassy/watery/bloodshot eyes, dilated pupils and the odor of an alcoholic beverage on his breath. Alejandro used his vehicle for support and exhibited orbital sway where he stood. Alejandro was unsteady on his feet at times but did not complain of any injury, refusing rescue.

I spoke with Alejandro who told me a convoluted story, that did not make much sense to me. Alejandro said he was driving when he lost his brakes and control of his vehicle striking cars on Southard St. Alejandro said he continued West on Southard St, until he crashed again at the North West corner of Simonton St and Southard. Alejandro said his tires then blew out and he put the car in reverse and parked on the sidewalk in front of 629 Simonton St on his rims. This made little sense to me as Alejandro said he had no brakes, but still managed to stop, put his car in reverse, do a u turn and drive North on Simonton St, instead of pulling over on Southard St or leaving the car where it was as it had no brakes.

I could see damage to the curb at this location as well as a line cut into the road from Alejandro's rim all the way to where the vehicle rested.

Ofc. R. Bulnes, Sgt. R. Allen, Ofc. S. Standerwick and Ofc. J. Calvert arrived on scene to help gather witness information and block traffic, as well as locate victim vehicles.

Ofc. Hall began his traffic investigation as I waited with Alejandro.

Officers interviewed witnesses to the crash and collected witness statements later provided to KWPD records.

Witness Statements provided by Edward Gore, Nancy Gore, Chris Shullz, Nancy Hillman, Glenn Rogers and Kari Dangler all described Alejandro's vehicle.

According to the various statements and Ofc. Hall's crash investigation at the scene, I concluded the following:

Alejandro's vehicle revving it's engine, at William St and Southard St, attempting to turn West on Southard St. Alejandro losing control and driving unto the South side sidewalk of Southard St, cutting the vehicle short and crashing into the drivers side of the first parked vehicle, getting stuck and driving his car free.

A female passenger (later identified as Melinda) yelling let me out. Alejandro then driving forward on the sidewalk, crossing over into the roadway, with squealing tires and crashing into another parked vehicle located on the North side of Southard St and fleeing the area at a high rate of speed without stopping and providing his information (fleeing the scene of a two victim vehicle crash). Alejandro then attempting to drive North on Simonton St with blown out tires and crashing into the North West curb on Simonton at the intersection. Alejandro then reversed at a high rate of speed (tire marks in intersection) and attempted to flee North on Simonton St, finally stopping due to severity of damage partially on the sidewalk in front of 629 Simonton St.

Witness statements described Alejandro speeding, crashing, driving on a sidewalk, fleeing the scene of an accident, crashing again, fleeing the scene of the second accident and crashing at the intersection of Simonton St and Southard St, attempting to flee again and breaking down in front of 629 Simonton St leaving vehicle parts in his wake.

Ofc. Hall interviewed Alejandro and informed Alejandro upon completion of his crash investigation.

I then informed Alejandro that I would be conducting a DUI investigation and informed him of my observations. Alejandro did admit to drinking the prior and having gone to sleep this morning at approximately 0330hrs. I asked Alejandro to participate in Standardized Field Sobriety Exercises, to dispel my belief that he was operating a motor vehicle while under the influence of an alcoholic beverage and/or a controlled substance and he said yes.

Alejandro was slow and deliberate throughout the exercises and even changed shoes.

Horizontal Gaze Nystagmus: Alejandro exhibited orbital sway during the instructional phase. Alejandro had difficulty maintaining the starting position and following instructions. Alejandro exhibited dilated pupils, lack of smooth pursuit, maximum deviation, onset prior to 45 degrees and vertical gaze nystagmus in both eyes.

Walk and Turn: Alejandro had difficulty maintaining the starting position during instructional phase. Alejandro took an incorrect number of steps, missed heel to toe and stepped off the imaginary line.

One Leg Stand: Alejandro exhibited orbital sway during the instructional phase. Alejandro placed his foot down for a long moment and corrected himself.

I placed Alejandro under arrest for DUI at 1009hrs.

Search incident to arrest I located a small silver spoon in his shorts pocket with a white powdery substance on it clearly indicative to me as a spoon used to snort narcotics (later FTP cocaine by Ofc. J. Calvert).

## Incident Report

I read Alejandro Implied Consent and he told me he would provided a breath sample. I read Alejandro his Miranda Warnings and he wished not to speak to me all though he continued to speak.

I left the drug paraphernalia with the cocaine residue in Ofc. Standerwicks possession (so he may field test it and drop it into evidence) as he searched the car and had the vehicle towed by Arnolds Towing.

I transported Alejandro to jail at 1026hrs and began the observation period.

Once at the jail. Ofc. M. Pettee met with me to operate the Intoxilyzer 8000, S/N 80-000870. Ofc. Pettee also read implied consent to Alejandro in reference to a breath test. Alejandro submitted.

Results were: 1st breath/0.061 at 1101hrs and 2nd breath/0.060 at 1104hrs.

Due to my training and experience, the Field Sobriety Exercises and the narcotics located on Alejandro's person I believed him to be impaired from a controlled substance and request a Drug Recognition Expert, Ofc. A. Rodriguez respond to the jail to conduct further exercises and a urine sample.

Ofc. A. Rodriguez arrived at the jail at 1134hrs and read Alejandro Implied Consent once again, requesting a urine sample. Alejandro refused and argued saying he believed he would not pass a urine sample as he had consumed cocaine and marijuana earlier this week.

Ofc. Rodriguez completed a refusal affidavit for the urine sample not provided by Alejandro.

Ofc. Hall arrived at the jail and issued Alejandro the following citations: A4QU64E Driving on roadway laned for traffic, A4QU63E driving on sidewalk and A4QU62E Careless.

I issued Alejandro Criminal citations: A4QU66E Fleeing scene of a crash 1st vehicle, A4QU67E fleeing scene of crash 2nd vehicle, A4QU65E reckless driving, A0LK9NE DUI property damage and injury and A0LK9ME DUI refusal to submit urine. Court Information: 302 Fleming, Judge Fowler, 04/28/16 at 0900hrs.

Alejandro received all citations, acknowledged understanding and received a copy.

I also charged Alejandro with possession of cocaine and paraphernalia for the cocaine and its device located in his pocket search incident to arrest.

This case is cleared by arrest.
