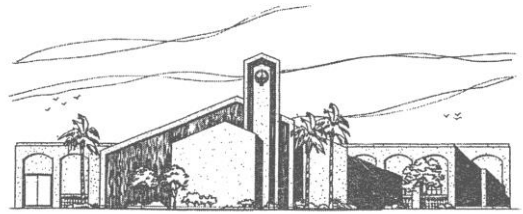

Parent Participation Commitment Options: We rely heavily on parent participation for our religious education program to operate. If we don't have enough volunteers to teach and assist in the classrooms, then they will be closed for the day. To prevent this from occurring, please choose one of the two **parent participation options** for your family and I will be in touch with you in regards to scheduling.

• Lead Teacher

Adapt lessons from our Tapestry of Faith Curriculum and learn about Unitarian Universalism from a unique hands-on perspective. This year I am seeking teachers for K-4th and 5th and up classrooms. With enough rotating teachers, this will be a commitment of once every 4-6 Sundays from September through mid-March. This spring, I will be lead teaching a special disability awareness class each week.

• Teaching Assistant

There needs to be two adults in every classroom for safety, classroom control, and assistance with projects, stories and discussion. There is no prep for this position. This year I am seeking teacher assistants for K-4th and 5th and up classrooms. This will be a commitment of 6 Sundays, per family, regardless of how many children are registered in the program, between September and May.
