Transfers will be approved in accord with Chapter 1, Section 16a of the Obedience Regulations, provided that a written request is submitted to the Trial Secretary at least 30 min. prior to the start of the Trial, and that the limit has not been reached in the requested class.

This Obedience trial will use small to tall jump height order. This Rally trial will use small to tall jump height order Please include dog's jump height on your entry. If jump height is not provided, height will be assigned based on breed of dog and best estimate of height.

A limited number of catalogs will be available at the Trial for \$4.00 each. You may pre-order a catalog for \$3.00 by including payment with the entry fee.

Qualifying scores are required for all awards.

The club reserves the right to substitute a prize of equal or greater value. All awards must be claimed the day of the show – None will be mailed. Unclaimed prizes become the property of Gem City Agility Club.

Crates may be left inside the show facility overnight in designated areas; dog may not be left overnight. Crates must not block entrance or exit of doorways or use prime parking areas. No X-pens.

No smoking is allowed in the building. No alcoholic beverages are allowed on show grounds or in parking areas.

Entries fees will not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Trial Committee. No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strikes, or any other cause beyond the control of Gem City Agility Club.

A refund of all but \$3.00 of each entry fee per day will be made to an exhibitor with a bitch that has come into season after the close of entries, providing that a statement from a veterinarian is submitted to the Trial Secretary no later than one hour before the beginning of judging on the day of the Trial.

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Refunds for females in season (after closing date) will be given upon satisfactory verification of bitch being in season less \$5.00 processing fee; satisfactory evidence may include vet's statement; notice to be given per AKC rules Chapter 1, Section 14.

Gem City does not agree to arbitrate claims as set forth on the official AKC entry form for these events.

No meals will be served on site. There are a few fast food restaurants in the area or you may bring your own lunch.

Gem City will follow State of Ohio guidelines for Montgomery County and City of Dayton for COVID-19.

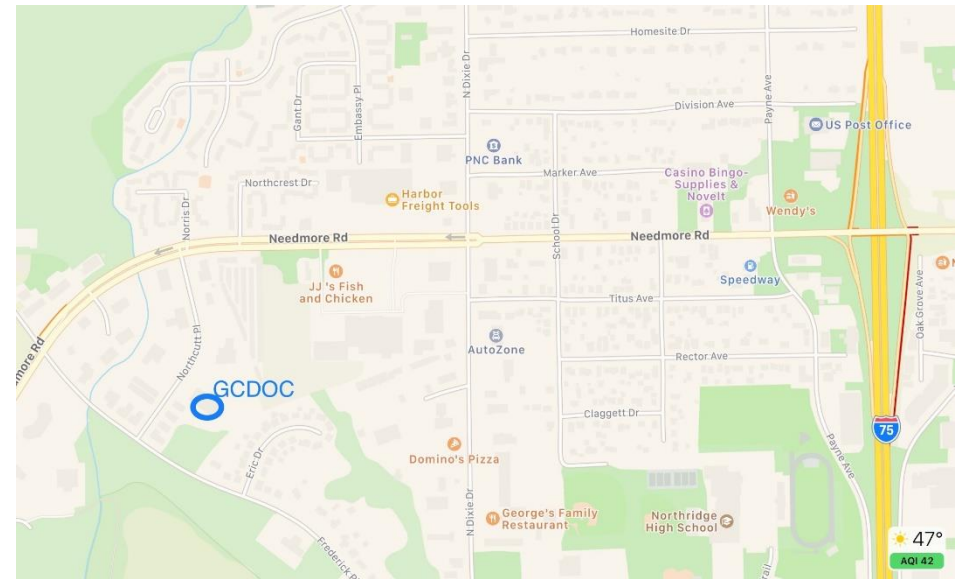

DIRECTIONS TO THE TRIAL SITE

Directions: 4920 Northcutt Place Dayton, OH 45414: From I-75 North or South, take exit #58, Needmore Rd. Go west on Needmore Rd. If driving South on I-75 turn right. If driving North on I-75 turn left. Go 0.9 miles (past North Dixie Drive) and turn left on Northcutt Place. The Gem City Dog Agility Club (GCDOC) building is 0.2 miles on the left.

There are 4 left turn lanes after Dixie: #1 (Closed) Kroger, #2 for JJ Fish & Chicken, #3 for a storage facility, and #4 is for Northcutt Pl. Gem City is on the left, the building is at the top of the hill.
