Camping trailer and RV parking sites are restricted to the campground only. **There will be a \$50 per site non-refundable deposit to hold your site.**  
There are three types of sites available:

1. **Full Hook Up** – Offers Electric, Water and Sewer (grey-water only) – approximate size is **18' x 35'**. These spaces are \$35 per night. Slide-outs are an additional \$20 for the duration of the permit (limited to one-side). One air conditioner is included in the price. Each additional air conditioner will be \$10 per permit (not per night).
2. **Compound Parking** – (Electricity Only) – spaces are approximately **20' x 40'** or as grouping configurations are approved by Fair Management. These spaces are \$25 per night. Slide outs are an additional \$20 for the duration of the permit (limited to one side). One air conditioner is included in this price. Each additional air conditioner will be \$10 per permit (not per day).
3. **Primitive** - No electricity, no water and no sewer are available – approximate size is **20' x 40'**. These spaces are \$15 per night.

For **Compounds Parking** and **Primitive Camping** on site, sewage dumping facilities are available in the campground facility across the road and commercial pumping and water filling will be available for an additional cost. Showers and restrooms are available on-site.

## CAMPGROUND RULES AND REGULATIONS

1. NO campground site can be sub-let to anyone for any reason or purpose.
2. Only ONE car, truck, SUV, etc. is allowed on site. In addition, there may be only one recreational vehicle allowed, which must have a permit.
3. Open burning is allowed in approved fire pit.
4. Pets are allowed and must be contained or tethered at all time. You are responsible for cleaning up after your pet.
5. Issued permits must be displayed so as to be visible to Emergency/Security/Fair personnel at all times.
6. All unites must be checked in prior to parking or setting up on designated sites.
7. All damages to electrical pedestals, water hydrants, sewage receptacles, electrical panels, showers, toilets, buildings, etc. must be immediately reported to Fair personnel. (Grey water cannot be dumped on the ground – parties violating this will be fined and possibly removed from property without refund of unused portion of facility rent.)
8. All campers must comply with all State and Local Health Standards and keep their sites and surrounding areas neat and clean of all garbage and rubbish.
9. Fair Management reserves the right to, at all times, revoke any permit and evict the permittee and all other persons on site if there is dangerous, threatening, loud, obnoxious behavior or nay behavior that interferers with the health, safety and welfare of other campground permittees. Quiet times on the grounds are from 11 p.m. to 7 a.m.
