**UNDERTAKING IN FAVOUR OF DECCAN CHAMBER OF COMMERCE INDUSTRIES &

WHEREAS, We, M/S [] are a Custom House Agent/Freight Forwarder/ Consultant (Strike out which is not applicable) having our office at [] and holding CHA Lic No/GST Regn No./ CIN/ MSME Regn No. [], herein after referred as “**Applicant**” which expression shall unless repugnant to the context or meaning thereof be deemed to include his heirs, executors, administrators and assigns).

AND WHEREAS, Deccan Chamber of Commerce Industries & Agriculture, Pune is a Chamber of Commerce, having it’s office at 305, Gulmohar Centre Point, Near Viman Nagar Chowk, Pune -14, hereinafter referred as “**DCCIA**” which expression shall unless repugnant to the context or meaning thereof be deemed to include his heirs, executors, administrators and assigns)

AND WHEREAS, DCCIA is an authorised agency to issue Certificate of Origin (“**COO**”) – non preferential as per the provisions of Foreign Trade Policy and Hand Book of Procedure Vol – 1.

AND WHEREAS, DCCIA issues the COO physically as well as on line to the Exporters (both members and non members) who are registered with it and have executed “indemnity bond” in favour of DCCIA, as stipulated in this regard.

AND WEHREAS, Applicant is in the business of providing various services to Exporters and one of the services being provided by it is to apply and obtain COO on behalf of Exporters.

AND WHEREAS, Applicant approached DCCIA and requested to give it the facility of applying and obtaining the COO on behalf of it’s Exporters Client who are registered with DCCIA and have executed the indemnity bond in favour of DCCIA.

AND WHEREAS, DCCIA is willing to extend the requested facility to Applicant subject to it submitting an “Authority Letter” from it’s Exporter Client inter alia authorising the Applicant to obtain the COO on it’s behalf from DCCIA and also submitting an unconditional “Undertaking” in favour of DCCIA.

NOW THEREFORE, IN VIEW OF DCCIA WILLING TO EXTEND THE ABOVE FACILITY IN FAVOUR OF APPLICANT SUBJECT TO THEM GIVING AN UNDERTAKING, THE APPLICANT GIVES AN UNCONDITIONAL UNDERTAKING AS UNDER:-

That the Applicant will be exclusively responsible for obtaining the Letter of Authority from it’s Exporter Client in favour of DCCIA including but not limited to verifying it’s genuineness.

That the Applicant will be responsible to ensure that all documents submitted by it to DCCIA for obtaining COO, on behalf of its Exporter Clients, are genuine. In case of any dispute between the Applicant and its Exporter Client regarding issuance of COO from DCCIA, Applicant alone will be responsible in this regard and DCCIA will have no liability in this regard.

That the Applicant will be responsible for making payment to DCCIA towards its charges for issuance of COO as well for certifying other documents in accordance with rates stipulated by DCCIA from time to time.

That in case any claim/loss/damages is caused to DCCIA due to it accepting the request of Applicant as detailed herein above, the Applicant will always keep the DCCIA indemnified against such claim/loss/damages, including but not limited to the legal cost and other cost which may be incurred by DCCIA in defending such claim.

That this undertaking is subject to the jurisdiction of appropriate courts within the city limits of Pune.
