



Pet Waiver and Release of Liability

In exchange for attending with my pet to the KW Pet Expo, located at the Kitchener Memorial Auditorium Complex on May 1 and/or May 2, 2021, and organized by KW Expo Productions Inc., I agree and acknowledge to the following:

1. I agree that my pet has received and is current with rabies and distemper vaccinations.
2. I agree that my pet will be on a leash not exceeding four feet in length.
3. I agree that I will immediately report to show staff or first aid if an incident occurs and keep my pet available until I have received instructions from the show staff or local authorities regarding the required procedures.
4. I agree that my pet is legal to own in the City of Kitchener, and conforms to all City by-laws.
5. I agree that I will keep my pet out of the assigned designated areas.
6. I agree that I will be in control of my pet at all times.
7. I acknowledge that my pet is not of an aggressive nature, is not in heat and has not had any incidents of biting or showing aggression in the past.
8. I acknowledge that I am the only one responsible for any harm, injury (personal or otherwise), illness or damage caused by my pet and I agree to indemnify and hold harmless any other person, company or organization from any liability resulting from my pet's attendance at the Expo.
9. I agree that my pet has never caused bodily or property damage.
10. I agree to accept full financial responsibility for any and all damages to persons and/or properties as a result of my pet's actions at the KW Pet Expo.
11. I acknowledge that if my pet displays behaviours that are deemed to be disruptive or dangerous, I may be asked to leave without reimbursement.
12. I agree to keep my snake, reptile, arachnid or terrarium dwelling pet confined at all times.
13. I agree that my pet(s) may be videotaped, photographed and or recorded. KW Pet Expo shall be the exclusive owner of the results and all proceeds of such media.

I am aware that during the course of my visit at the KW Pet Expo certain inherent risks are involved because I am attending with my pet. In consideration for being allowed to attend the KW Pet Expo with my pet, I agree to assume full and total liability for any and all damages including but not limited to injury to a person, property, or other pet that are alleged to have been caused in total, or in part, by the direct or indirect activities of my pet, me, and/or other persons attending the KW Pet Expo with my dog. I agree to hold harmless and indemnify KW Expo Productions Inc., The Corporation of the City of Kitchener, and all officers, agents, employees, managers, owners, volunteers, attendees and other individuals or entities involved with the production of this event from and against all loss, cost, damages, expenses and liability, from any cause of action, that directly or indirectly involves my dog.
