Approve Minutes of Previous Meeting, April 7, 2021

Old Business

The Proposed Marijuana Ordinance was tabled until after the budget workshops and town meeting. If the Select Board approves the Ordinance, the Board is asking the Town to “opt-in” to the sale and distribution of retail marijuana. If the Ordinance is approved a fee schedule will need to be approved. There is also an additional cost to the town for the Sheriff’s Department to enforce the ordinance.

Motion by **Dunlavey** to not approve the Proposed Adult Use and Medical Marijuana Business Ordinance as written due to the cost prohibitive measure of law enforcement.

New Business

Due to unexpected damage to roads this past winter, there will need to be a change to the paving schedule. A new schedule has been presented to the board.

Bid proposals were received for the 2021 – 2023 fiscal years from RHR Smith & Company and Chester M. Kearny. Chester M. Kearny was the lowest bid. This is informational only and the bid award will be voted on at the Joint Board meeting scheduled for May 18, 2021.

Per the Joint Board meeting it was agreed that the provided specifications proposal out. The proposals were opened on April 30, 2021. The Towns received proposals from Daigle & Houghton, K & T Equipment, Northeast Emergency Apparatus, and Greenwood Emergency Vehicle. The lowest proposal was from K & T Equipment. This is informational at this time. Fire Chief Adam Rider will present the Committee's recommendation at the Joint Board meeting scheduled for May 18, 2021.

Town Manager Report

The solar farm on the Hughes Road was approved by the Planning Board. This will generate revenue for the town. The Town Manager will be working with Trio to update the financial software. The Mapleton Lions Club will be hosting the Memorial Day Parade on Monday, May 31, 2021. The Treasurer/Tax Collector has sent out notices for unpaid 2020 taxes. Liens will be put in place on May 17, 2021. The Recreation Department is up and running with all activities being offered to the children this year. Annual training will be held for summer staff and employees in June.
