Regular Monthly Meeting
January 16, 2020

Present were Supervisors James Seltzer, and L. Gene Zinck.

Chairman James Seltzer called the meeting to order and Brent Petrosky led the Pledge of Allegiance.

The Minutes of the December 19, 2019 Regular Monthly Meeting and the December Treasurer's Report were reviewed.

The Minutes of the January 6, 2020 Organizational Meeting were reviewed.

Correspondence-Board Members reviewed the following items of correspondence:

1. County Conservation District Dirt & Gravel road Funding Application
2. Code Inspections construction permit
3. Citizens Hose Co. activity report

Road-master's Report - Road-master Gene Zinck related the following activities since last meeting:

1. Cleaned out a pipe end along Dennison Hollow
2. Earl Stroble has plowed and cindered on several occasions
3. Removed downed trees from Furnace Run and Fillman roads
4. Replaced a hydraulic hose on the truck plow
5. They've set a new propane tank
6. Cleaned the shop floor and installed the broom on the John Deere

Zoning Officer's Report – Brent Petrosky advised that he has issued no new permits since the last meeting. Brent is reviewing a permit application for a split rail fence on Creekside Drive.

EMC Report – Gene Zinck provided the activity report from Independent Hose Fire Department.

Recreation Committee Report- Nothing new to report.
