**CAPITAL PROVIDER NOTICE OF INTENT TO FUND PROJECTS
IN THE MONTGOMERY COUNTY C-PACE PROGRAM**

PROCESS:

1. The Montgomery County C-PACE Program does **not** require that capital providers register to be active in the program. However, they may choose to submit this form to the program administrator: info@paceservicing.com if they wish to be listed on the program’s website.
2. Following submission of this form, the interested party will be considered an Active Capital Provider in the Montgomery County C-PACE program. Active Capital Providers will be listed on the program’s website and will be provided a digital “badge” indicating program activity for professional use.

Note: Regardless of whether a capital provider has previously submitted a Notice of Intent, all capital providers will be required to execute a Standard Offer prior to funding their first C-PACE deal in the county.
