Holyoke Gas & Electric and NEPPA have a joint contract with McFarland Cascade Holdings, Inc. ("McFarland"):

- HG&E Department Contract # 18-41

As you are aware, McFarland Cascade merged into its parent company, Stella-Jones Corporation ("Stella-Jones") on December 31, 2019.
