We understand that, as a convenience to us, who is an authorized Ford and or Lincoln Mercury dealer and who requests Ford to do so, Ford is willing to collect the per unit sum which we have agreed to remit to the Fund by adding the amount thereof to the dealership invoice for each new Ford or Lincoln Mercury car and truck ordered by us, and to transmit the same to the Fund. It is understood, of course, that in collecting and transmitting such sum, Ford acts only as a collector and has no interest or responsibility other than that of transmitting the sum collected to the Fund.

This request and authorization is effective as of \_\_\_\_\_ and shall remain in effect until such time as FORD MDA may notify Ford in writing to the contrary. Once this request is received, it may take Ford up to 60 days before enrollment is recognized in Ford systems and dealer begins contributing to Fund. Earliest effective dates will not be prior to initial system installation, no earlier than 7/9/06. A request received by Ford from FORD MDA, may also take up to 60 days for Ford systems processing.
