**MEMBERSHIP BENEFITS**

All membership categories include the following member benefits:

**COMPLIMENTARY TICKET RESTRICTIONS**

- Complimentary tickets will be honored after passengers with pre-sold tickets are boarded.
- Members looking to use their complimentary tickets must alert Purser at the dock so they can be boarded prior to walk-up ticket sales.
- Membership card must be present for Purser to verify valid complimentary tickets & punch card.
- Unpunched tickets will remain valid until used.
- Advance reservations will not be accepted for use of complimentary tickets.
- Per IRS regulations, redeemed complimentary tickets should be counted as value received for tax purposes.

**MLM HALL OF FAME MEMBERS**
