Here is some important information.

Entrance to the facility. Only one entrance to the facility will be open - on the North East side, by the covered arena 5A. All other entrances will be closed. There will be an attendant posted at the gate, who will collect signed release forms from those who did not send their forms with their entries, and for those wishing to enter the facilities. All riders who sent in their release forms will be on our master list. You will be asked to wear a bracelet to indicate you have signed the release form. If for some reason there is no one at the gate to receive you when you arrive, please make sure to check with the Show Office and ask for your bracelet. This will help our TD ensure that we have complied with USEF requirements on COVID-19. Please bring a mask or face covering with you, if you forget to bring a face mask, we will provide you a mask. As per USEF rules all those at the show grounds must always wear a mask unless mounted on a horse.

Arenas: We'll have one ring set up in Equidome, two rings in the arena WestWorld designates as 4, and one ring set up in the arena WestWorld designates as 5. Warm-up will be in the covered arenas and lunging will be in Wendell.

Purchase additional bedding from West World. The show provides two bags of shavings. Call WestWorld at 480 312-6814 to order additional shavings. You'll need your stall assignment and arrival day. Feed and bedding office hours are 8 AM to 5 PM.

Golf Carts. Please bring your driver's license when you come to pick up your golf cart. Reminder: One must have a driver's license to drive a golf cart.

Bridle Numbers: USEF Rules require that numbers be displayed whenever horses are out of their stalls. Please check in and obtain numbers prior to working horses.

Move-In begins Friday after 6:00 AM. Move-out is no later than 6 AM Monday. If you're planning to arrive on Thursday, you **must** call our barn manager Laura Borghesani at 602 320-6613 to arrange an arrival time. She will not be on the property full time. Failure to arrange a time in advance means you'll most likely be on the showgrounds with no one to unlock your stalls.

Arena Access: All rings will be open Friday as early as 6 am, but ring set-up will be a priority, so access may be limited while the ring is being set. **No arenas will be open on Thursday.**

Show Days: During the show, competition arenas will be open to hand walking only outside the dressage court up to one half hour prior to the beginning of the show and mounted schooling in arenas is permitted after the end of each competition day. Equidome is open after the show concludes so riders can stay late.

- Parking, food, and alcohol policies established by the City of Scottsdale will be **strictly** enforced.
