

Property Improvements

- Building Permits are required in City limits and based upon valuation (material and labor cost) of project.
- Plot Plan is needed for:
 - Residential buildings and additions
 - Accessory buildings
 - Decks, porches, gazebos, awnings
 - Garages
 - Pole barns
 - Storage buildings
- Before beginning a project, please call or stop by City Hall to start the permit process.

Dogs

- All dogs must be licensed annually.
- Licenses are available January 1st. A \$15 late fee is applied on April 2nd.
- Proof of rabies vaccination is required prior to licensing. Please bring paperwork from the vet.
- Maximum of 3 dogs allowed in City limits.
- To report nuisance barking, animals at large, or other animal related issues call Dispatch at 983-1351 Select "0".
- Dogs are not allowed in City parks except as designated on the east side of Lions Park.

City Utility Bill Payment Options

- Online at www.grangeville.us. Click Pay Utility Bill.
 - ◇ **Owners**—Register the account to keep payment information, set up auto pay or go paperless.
 - ◇ **Renters**—Click Pay Now, enter account number and house number only to pull up invoice.
 - ◇ Pay by electronic check—free
 - ◇ Pay by Debit/Credit card—\$3.95

 - ◇ Use after hours drop box to the right of front door, on North Street.

Trees

- Trees located in the right-of-way are the responsibility of the property owner.
- Must have City Council approval to plant or remove trees from right-of-way.

City Council Meetings

- 1st & 3rd Monday of the month – 6pm
- Open to the public.
 - Contact City Hall before 5pm the Thursday before the meeting to be added to the agenda.

Garbage pick up

- South Side—Friday morning
- North Side—Monday morning
- Move totes to the street the night before pickup.
- Move back off the curb & street after pickup.
- There is no alley pickup.

Yard Waste

- May 1-August 31 (subject to change).
- Yard waste is collected Monday for the entire City and should be kept separate from regular garbage.
- Seasonal rate of \$30 billed directly by Walco. Call 983-1550 to order a tote.
- Extended pickup for leaves is available upon request at \$5 per month. Call Walco to order.

Trailer Parking

- A permit is needed for any trailer parked along the street for over 24 hours.
- Obtain a 21 day permit at City Hall or print the form from our website under forms and submit to City Hall.

Property Maintenance

YARDS

Please keep grass and weeds trimmed and keep property free of trash & debris.

SNOW REMOVAL

The property owner is responsible to remove snow and ice from sidewalks adjacent the property.

SIDEWALKS

Sidewalks are to be repaired and maintained by the property owner. Sidewalk, curb & gutter installation required if new construction or remodel valuation is \$75,000 or more.

HOUSE NUMBERS

Please make sure your house number is visible from the street to aid in emergency response.

Burn Permits

- Burn Permits are required May 10 - November 10 and cost \$100.
- Call or stop by City Hall to fill out the Permit.
 - Permit application with a list of prohibited items can be printed from our website under forms and submitted to City Hall.
 - Permit must be approved by the Fire Chief and on site during the burn.
