Crossroads Kids Club exists to mobilize God's people to share the Good News in public schools through church-led clubs. (See attached full description).

Connection and Capacity Building: In the past fiscal year, we have grown from 33 to 45 club locations, and we served over 1,300 children. To continue opening new clubs requires us to connect churches, schools and donors together in order to provide the people, space and resources needed to implement a thriving after-school club. To that end, Crossroads worked to educate church and school leaders about the nuances of church and state separation, to cast vision to ministry and school leaders and to cultivate community relationships resulting in healthy partnerships for the good of children. One key area of growth was the development of a formalized process for connecting with new church partners. We pursued individual appointments with church leaders as well as a pastor informational luncheon event and Zoom conference meetings.

Program and Curriculum Development: Crossroads continued producing curriculum for use at its Kids Club sites. A brand new series was produced entitled God's Wise Design. This is a 25-lesson curriculum teaching children stories from the Bible and helping them to make wise decisions according to God's Word. We continued working with a curriculum advisory team comprised of key volunteers to help broaden the appeal of the activities included in the lessons. Additionally, Crossroads produced a series of monthly parent newsletters that align with the curriculum as a tool to engage the families of the children in the clubs. For the third year in a row, Crossroads has translated the entire curriculum into Spanish to serve Spanish-speaking students and volunteers. Another program See Part III, Ln 4b statement

Coaching and Training of Leaders: Crossroads continued to develop resources and training for the more than 300 leaders serving in our Kids Clubs. Resources developed this year included content in an online leader resource blog and coaching sheets for team leaders. As well, we hosted a 3-day leadership training retreat for new team leaders. Finally, we implemented a leadership internship program to develop young people.
