

## Lakeside Arena AQHA 2020 Shows 2020 COVID-19 Procedures

Thank you for your continuing support of Lakeside Arena shows. Under the new circumstance of the pandemic, we will do our best to make the show experience an enjoyable one. With our new Covid-19 guidelines in place, we will be following the Commonwealth of Kentucky Governor's [KYHealthyatWork](#) Requirements – Horse Shows. We thank you again for supporting our horse shows and we will try to make this new process easy as possible.

**Office Procedure:** We will be accepting online entries ONLY. All entries will need to be made online at [www.horseshowing.com](http://www.horseshowing.com). (Due to [KYHealthyatWork](#) Horse Show Requirements.) This includes ALL HORSES, showing or not. NO PAPER ENTRIES WILL BE ACCEPTED. PRE ENTRIES ARE DUE WEDNESDAY 6:00 pm prior to the weekend of the horse show. All entries received after this time will be considered a LATE ENTRY and a \$25.00 late fee per horse entered will be assessed. All entries are to be done per Trainer/ Agent if you are showing by yourself you are considered the agent. Horseshowing.com will be charging a per horse subscription fee. Horseshowing.com is very user friendly. Any questions with entries and setting up horseshowing.com can be directed to **Lynn Johnson (859)396-9633**. All check-ins and check-outs will only be done by Trainer/Agent to help stay in compliance with our COVID-19 guidelines. Trainers/ Agent will collect all clients' checks and pay bills at checkout. At check-in, one open check will hold entries per Trainer/Agent. Trainer sheets (download from [www.lakesidearena.org](http://www.lakesidearena.org) or [horseshowing.com](http://horseshowing.com)) **must be completed and turned in at check-in** for correct allocation of tack stall and/or extra shavings. At check-in and check-out, please have all your paperwork ready so that we can have an efficient process. Please bring your own pen to check-in/check-out to help eliminate any possible cross contamination. **ALL TRAINERS/AGENTS MUST WEAR A MASK AT THE OFFICE.** ALL Stalls and/or Shavings orders must be ordered by texting **Bruce Brown (859) 489-4885**. **Text must include your name, number of stalls needed and number of extra shavings. EVERY HORSE MUST HAVE A STALL. No working from trailer.**

**Upon Arrival:** All vehicles arriving will stop at arrival check point. All people entering facility will be required to have a signed new COVID-19 waiver on file with Lakeside Arena. Please download, print and sign waivers from our website [www.lakesidearena.org](http://www.lakesidearena.org) or [www.horseshowing.com](http://www.horseshowing.com) to help expedite the arrival process. You will be checked each time you enter the property.

### **Schooling/ Hours of Operations:**

- Gates will open **Friday at 8:00am** and close Friday at 6:30pm for new arrivals. Rings will **close at 7:30pm and facility will close at 8:30 pm. Arrivals BEFORE or AFTER these times MUST contact Bruce Brown at (859) 489-4885'**
- Schooling will be allowed with 10 people per ring including mounted riders/ trainers and/or unmounted trainers at a time.
- Show days gates will be open from 5am- until one hour after the show has been completed.
