OLD BUSINESS:

The Supervisors are continuing to review the Township's Floodplain Maps. Maps are available for the public to review at the Township Building by appointment.

The Board has not yet received a response to their letter dated April 4, 2011 to the Water Authority requesting inspection of the 49 fire hydrants in the Township.

The Board has not yet received a response to their letter dated May 24, 2011 to the Water Authority requesting copies of the charters for the Water Authority and Sewage Authority.

NEW BUSINESS:

A motion was made by Jim Rumble and seconded by Lou Kovach to appoint Jeff Novak to the Greensboro-Monongahela Township Joint Sewage Authority for a six-month term (7/1/11 – 12/31/11). The motion passed unanimously.

Jim Rumble will contact Attorney Hook regarding harassment by a Township resident stemming from an incident on Friday, June 3, 2011 at the Township Building.

A motion was made by Jim Rumble to accept a bid from Superior Seamless Gutters to replace the gutters and downspouts on the Building at a cost of \$1700. The motion passed unanimously.

A motion was made by Jim Rumble to accept a bid from Superior Seamless Gutters to prep and paint the Township Building to match the lean-to at a cost of \$3320. The motion passed unanimously.

The Board agreed to bill the Sewage Authority \$1,875.00 for work done on the Mapletown Pump Station and the Greensboro Borough \$1,983.00 for salt and ashes used to date.
