APPROVAL OF MINUTES: Lou Kovach made a motion to approve the minutes from the February meeting. Bill Monahan seconded the motion and the motion passed unanimously.

NEW BUSINESS:

Bill Monahan made a motion to adopt the holding tank rules and regulations pursuant to Township Ordinance #2 – 1985 as prepared by Attorney Hook and Sewage Officer Tim Neil. Lou Kovach seconded the motion and the motion passed unanimously.

Bill Monahan informed those in attendance that the Supervisors have worked on Sit Still and Kois Roads in the past month. Work has also begun on Kovach Road.

Nancy McIntire informed the Supervisors that the 2011 Township Audit has been completed and will be sent to the newspaper for publication.

PUBLIC COMMENT:

Larry Rogerson had a question about the Supervisors' weekly work hours.

Jim Minor had a question about Jim Rumble's number of hours worked in the fourth quarter of 2011. Jim said he would research it.

Larry Rogerson had a question about gas well ordinances and decibel levels due to the passage of Act 13, State Bill 1950 on February 14, 2012. Bill Monahan explained that the County Commissioners may pass a county-wide ordinance. If not, individual municipalities will have to pass resolutions to qualify for state gas well monies.

Larry Rogerson had a question about the existence of an old Township ordinance regarding the clean up of broken down properties. Jim Rumble explained that Attorney Hook addressed this issue previously and decided that it would not be cost-effective to take on these projects.
