

**TOWN OF KING
TOWN BOARD MEETING**

Unapproved Minutes July

Monday-July 12th, 2021

- Chairman Wiese called the meeting to order at 7:00PM
- The Pledge of Allegiance was recited
- Roll call of officers: Chairman Wiese, Supervisors Tomaszewski & Martello, Treasurer Allen & Clerk Linden were present.
- First public forum-brief concerns or questions: None noted.
- Approval of Agenda-There was a Tomaszewski /Martello motion to approve the agenda. Motion carried.
- Voucher Approval: Wiese/Tomaszewski motion to approve the vouchers. Motion carried.
- The Treasurer's report for June 30th, 2021 shows an opening balance at Tomahawk Community Bank of \$340,098.63. June deposits of \$50,438.97 withdraws of \$30,021.37 with an ending balance of \$360,516.23. This balanced with the Clerk's records and the Bank. Tomaszewski/Martello motioned to accept into records. Motion carried. Treasurer Allen, confirmed receipt of \$44,274 from ARPA -the monies were added to our account on June 25th.
- Minute's approval for the June 14th, 2021 regular town board meeting. Tomaszewski/Wiese motioned to accept the minutes into record. Motion carried.
- Correspondence: Chairman Wiese/clerk received notice from Lincoln County for changes on Conditional Use permits with a 30-day extension.

OLD BUSINESS

- Liquor License approvals.
- Conditional Use Permit for Scott Mills. – was Ok'd per Lincoln County recommendations.
- Callahan Rd Property- Tomaszewski reported updates with the Realtor. Board agrees to start surveying the property. Update again at August meeting.
- Town Rd updates-Wiese confirmed crack sealing to begin by end of week- and chip sealing mid-August.
- ARPA Funds- Filing has been completed/monies received - Treasurer Allen will look into possibilities of putting funds into a new account with better interest rates.

NEW BUSINESS

- Road Repairs- Wiese reported weight restrictions to be lifted on Lily Lake/Spring Creek Rds as of 7-13-21. Chairman Wiese and supervisor Martello will take pictures/videos of the roads to determine if any further damage is being done to the roads by trucks hauling in this area. Haulers agree to report any damage as it occurs and will work with the Town to help maintain the roads as work is being done in this area. Also discussed possible signage for these roads to help limit speeds/inappropriate use by all vehicles/UTV/ATV's.
- Conditional Use Permit – Dave Bethel request for horse pasture on his property. This request will roll over to next month's meeting to wait for the Staff Report from Lincoln County.
- ARPA Funds- Board agrees to investigate further uses for the funds received- update again in August.
- Comments: any items not requiring board action: Agenda items for the next Town Board meeting: None noted.
