- The business owner will complete the Application and the Owner Application pages and pay for the permit.
- Each employee that will be in Grangeville will complete an Employee Application.
- Submit a clear copy of a driver's license for all applicants.
- The Police Department will complete a background check for the Owner and Employees. The background check can take up to 5 days to complete.
- Upon approval, the City Clerk will issue a Solicitation Permit.
- It is the responsibility of the owner to contact City Hall and receive a copy of the "do not call" registry for Grangeville.
