SCARECROW TRAIL GUIDELINES You can register as a family, business or nonprofit . We suggest tying your theme to your Business if possible and placing it outside you business. People following the Scarecrow Trail will find not only the Scarecrow but your business too!!

- To be eligible to be judged your Scarecrow must be part of the theme, and in place **no later than Tuesday October 1st.**
- Sturdy construction, able to stand up to bad weather, unique costumes, faces and accessories are encouraged.
- **Signs for each Scarecrow will be made by us (Rebecca Robinson Scarecrow Chair) and will include Scarecrow's name, business/organization/group and text # to vote.**
- Businesses and Organizations are encouraged to include their "signature" in the design of their Scarecrow.
- The committee reserves the right to eliminate a Scarecrow from the contest if it is deemed inappropriate.
- Judging will take place during through October 29th.
- Please make sure you put on the entry form the location of your scarecrow.
- Scarecrows must be in good taste. Please refrain from putting overtly political/religious/controversial messages on the Scarecrow
- Make your Scarecrow visible. Scarecrows must easily be seen from the street so that people taking a driving tour can see them.
- Whether funny, silly or ridiculous, or just plain cute this is your chance to express yourself and your business! Use your imagination (or that of your staff!), use discarded old clothes, hats, gloves, and any other accessories **you'll need to make** your scarecrow unforgettable! Use local produce and recycled items when building your Scarecrow.
- Scarecrows will remain in place until October 31st and must be removed no later than November 1.
- **If attaching your Scarecrow to a lamppost or power pole please use rope or zip ties. They must not be adhered with anything that could damage these fixtures, do not use duct tape, screws, wires etc. Scarecrows must not block or impede traffic in any way.**
- **DO NOT place in front of signs.**
