

**COASTAL BICYCLE TOURING CLUB
GENERAL MEETING
MARCH 2, 2020**

4. We have had the club picnic at Ft McAllister in the past. Other possible sites are at the Landings or the Macomber Recreation building in Rincon. The date has been set as May 2nd. A final decision on the location will be announced in the near future.
5. The club offered Sunday Sunset Rides last summer and plans to continue this year. We hope to offer them at Tybee Island along with the Landings. Members of other cycling groups and bike shops will be invited.
6. Rich Wharff volunteered to look into securing tickets for a club night at the Bananas ball game. Further information will be announced in the future.
7. The club will consider new ways for awarding the member of the year award and the Iron Keister award. There will be further discussion on this issue in the future.
8. Our Treasurer, Debra Griffith, will be moving to Florida sometime around May, 2020. John Arney, Secretary, will fill in for this position until a new Treasurer is installed in July.
9. The cut-off date for membership renewal is March 15th. John Arney is notifying all members who have not renewed that they will no longer receive correspondence from the club if they do not renew by this date. There are currently 87 listed members, but 21 of them have not renewed to date.

10. Club members are encouraged to volunteer to become Ride Leaders. The duties are fairly simple and there are detailed instructions on the website. We also need new bike routes for our Saturday rides.
