Drivers must have 2021 ARCA/CRA Driver’s License. Top 20 qualifiers must have purchased qualifying tires the day of the race. Tires will be Hoosier F45’s & F50’s. This is a 4-tire maximum event except for approved flats. Tires sizes may be pre-ordered from Clyde Moody, the series tire dealer at 706-878-7988. **Teams with haulers bigger than a box trailer will have to unload outside the track and push equipment to their pit stall, all haulers will park outside the track. Sunoco 110 is the Spec Fuel of the series, there is a mandatory 10-gallon purchase.** Minors 14-18 must have a minor's release signed at the track in view of the pit registrar. The release must be signed by the custodial parent or legal guardian. Proof of age and parental custody are required.
