- The Montcler Hotel and Resort garage sale will take place on Saturday, June 15, 2019 from 8am to 3pm. Spaces will be located in the parking lot in front of Montcler's Convention Center (3300 Drew Ave, Sandwich, IL 60548).
  - All reservation forms and payments must be received at the Sandwich Area Chamber of Commerce office **no later than noon on Friday, May 31st, 2019**. Spaces are assigned on a first-come-first-served basis. Participants will receive a phone call or email confirming their reservation.
  - Space fee is \$5 per parking space. Additional spaces may be purchased. The fee includes a standard parking space(s). Fees help the Chamber cover cost of printing, newspaper ads and publicity for the event.
  - Tables will NOT be provided. Tents must be secured. If you plan on using a standard 10x10 popup tent, you MUST purchase at least 2 spaces.
  - Sale of FOOD and FIREARMS is not allowed.
  - The Sandwich Area Chamber of Commerce and the Montcler Hotel and Resort reserve the right to close down any participant that does not comply with the rules & regulations set forth under the terms of this agreement.
  - The Sandwich Area Chamber of Commerce and Montcler Hotel and Resort assume no responsibility for the safety of the properties of the participant, its officers, agents or employees from theft, damage by fire, accident or any other causes whatsoever.
  - **Set up begins at 6:30am on Saturday, June 15, 2019. All items must be removed by 5pm the same day (June 15, 2019). To ensure the safety of the shoppers, driving up to your assigned space to break down is NOT ALLOWED before 5pm.** The Sandwich Area Chamber of Commerce and Montcler Hotel and Resort are not responsible for the removal of items or any items left behind.
