Imagine having to testify in criminal court.

The thought of going to court makes most adults uncomfortable. *Imagine being a child.*

The Child Witness Centre, through the Child Witness Program (CWP), works in partnership with the justice system and the community to provide support services and court preparation for victims and witnesses under the age of 18 involved in the criminal justice system in Waterloo Region, Guelph and Wellington County. We help children and youth find their voice during the court process.

Each year we assist over 500 children and youth:

- More than half are victims of crime. Four out of five of these are victims of sexual or physical assault.
- More than 90% of victims and witnesses are known to the accused.
- At least 98% of all cases involve abuse or violence.
- It may take two years or more for a child to go through the court process.

HOW WE HELP

- Working with Police and others to ensure that all children and youth are referred to us for support.
- Educating the child on courtroom procedures and their role as a witness.
- Helping the child understand and cope with their fears and apprehensions.
- Helping parents to be effective in supporting their child.
- Scheduling and attending pre-trial meetings with the Crown Attorney.
- Providing a child-friendly environment throughout the process.
- Assessing and advocating for the use of testimonial aids.
- Accompanying and supporting children in the courtroom.
- Assisting with Victim Impact Statements.
- Providing information on community resources and services.
- Explaining the verdict and the sentence.

OUR HISTORY

- 1981** - Citizens Concerned with Crime Against Children (4Cs) was established
- 1991** - The Child Witness Program was formed.
- 2002** - The agency was renamed Child Witness Centre.
- 2006** - The CWP expanded into Guelph and Wellington County.
- 2013** - The moved to its new 111 Duke Street home across from the Waterloo Region courthouse.
- 2016** - The Centre leads an initiative to establish a Child and Youth Advocacy Centre in Waterloo Region.
