### USES AND APPLICATIONS

**MOMENTUM De-icer** should be applied at the rate of one to two gallons of liquid per 100 square yards application area. The amount of MOMENTUM De-icer will vary depending on location, weather and timing.

**Anti-Icing (Pre-treat)** - To help prevent ice and snow from bonding to paved surfaces, apply MOMENTUM De-icer to paved surface prior to winter storm. Do not apply if raining.

**De-Icing** - Apply MOMENTUM De-icer directly to ice and snow to remove icy build up from paved surfaces. Depending on the snow/ice depth, repeated applications may be required.

### MIXING WITH SANDING MATERIALS

**MOMENTUM De-icer** can be premixed with sanding materials or added directly to sanding stock piles. To keep sanding piles fluid, add 2-4 gallons per cubic yard. To make an equivalent 15% sand and salt mixture, add 4-6 gallons per cubic yard. To make an equivalent 20% sand and salt mixture, add 6-8 gallons per cubic yard.
