## Application for Affiliation

### Competition Guidelines\*:

1. Zonals and Nationals will be conducted each year.
2. Gold Medal winners in Zonals will compete in Nationals.
3. Gold and Silver Medal winners at National level will be eligible for the National Team for Asian & World Championships.
4. All Selected athletes for International Events will have to attend a National Camp. Only Valid passport holders will be allowed to participate in the Camp.
5. National Camp shall also involve referee and coach training.
6. All rules of MMA, GAMMA-India shall be reinforced at all levels.
7. All decisions of the Referee, Judge are FINAL and no mis-behaviour towards them will be tolerated during the Championships.

### Rules and Regulations\*:

1. Any Club can belong to GAMMA-India and any other promotion. However, in the event of an athlete winning a spot on the National team, he/she will be under contract with GAMMA-India until the World/Asian Championships ie they will not be allowed to take part in any competition once spot on the National Team is confirmed (unless with the express written consent of GAMMA-India).
2. GAMMA-India Affiliates are expected to promote the art of MMA in a fair and transparent manner.
3. All GAMMA-India Affiliates and their athletes and partners are required to follow GAMMA-India's Sportsmanship and Code of Conduct.
4. All Affiliates and contestants agree to accept and respect GAMMA-India's bylaws, rules, regulations and policies governing the sport of MMA.
5. Discrimination on basis of gender, racial or ethnic origin, religion or belief, age, disability, sexual orientation or language are grounds of dismissal
6. Any Legal matter or issues arising or any dispute shall be subject to the exclusive jurisdiction of the courts of situated at Mysuru.
