| N A R R A T I V E | <p>1</p> | <p>Topic ORIGINAL</p> <p>15- 0643</p> | <p>On Saturday, February 7, 2015, at about 2130 Hours, I (Officer Janeth Calvert) was working an off duty detail at Ocean Key House, for the Revivals Concert. I was fully uniformed in my blue Key West Police issued uniform. My assignment was to secure the VIP entrance of the concert, located by the pier. I was approached by an Ocean Key House employee, later identified as Ryan Michael Gernaat (DOB 07/12/1985) regarding a female entering the VIP area without the proper bracelet. I noticed the female; later identified as Kelsey Nicole Hass (DOB 02/19/1993) pushed one of the barricades securing the VIP area and entered the secure VIP zone.</p> <p>I proceeded to stop her and told her she was not allowed in the VIP area unless she had the proper bracelet. Haas was escorted out of the VIP section. Approximately 20 minutes later, I was approached by Ocean Key House employee, Oksana Semasmko (DOB 11/21/1990) regarding a non-VIP guest dancing at the stage with the band and her dog. As I looked at the stage, I recognized the female as being Haas. Both Semasmko and Gernaat asked me to escort Haas out of the VIP area.</p> <p>At this point I walked over to the VIP area and saw Haas facing the band and dancing. Haas was holding her white dog in her left arm. I approached Hass from her right hand side and asked her to please walk outside of the VIP area with me. Haas looked at me and then turned to walk away from me. I then grabbed Haas by her right elbow with my left hand and asked her to please walk with me. Haas pulled her right arm from my grip and pushed me with her right hand.</p> <p>I then grabbed her right arm by the wrist and placed her in a shoulder lock. Haas dropped her dog on the ground and turned towards me, again pushing me away from her and disengaging from the shoulder lock. I asked for other Police assistance. I gave Haas loud verbal commands telling her to stop resisting. Haas continued to resist and disobeyed my loud verbal commands. I then grabbed her by her right arm and took her to the ground with a straight arm-bar takedown. Haas went straight to the ground. During the takedown, Haas scuffed both of her knees on the wooden pier. I handcuffed Haas and escorted her out of the VIP section. At this point, I asked for an on duty Supervisor to respond to the scene and collected witness statements from Gernaat and Semasmko. Sgt. R. Smith responded to the scene and completed a Response to Resistance Report.</p> <p>Kelsey N. Haas did knowingly and willfully trespass at the Ocean Key House VIP section of the pier after being warned not to do so, which is in violation of Florida State Statute 810.09(2b). During the removal process, Kelsey N. Haas disobeyed my lawful commands and resisted arrest by pushing me and pulling away from me, which is in violation of Florida State Statute 843.02. Haas was transported to Monroe County Jail without further incident.</p> |
