Illegible entries will not be processed and will be returned to the exhibitor or shredded. Please make sure we can read your entry! Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Wait List - SJDTTC is offering a wait list to fill openings created by withdrawn entries prior to the trial's closing date/time. A maximum of **10 entries** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to February 16, 2021, 5:00 pm. No entries may be withdrawn with a refund after closing on February 16, 2021, 5:00 pm. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

Bitches in season: Full refund will be given for bitches in Season after the closing date. You must request a refund in writing to receive a refund. The request must be received by the Trial Secretary no later than 30 minutes prior to the start of judging.

Rules for entering this trial:

- 1. DO NOT COME IF YOU FEEL SICK!!! (If the club is able to fill your entries from the wait list, your entry fees will be refunded.)**
- 2. DO NOT COME if you have traveled out of the state and have not sheltered in place for 14 days!**
- 3. DO NOT COME if you have been to any large gatherings within the 14 days prior to this trial!**

Grounds rules:

1. NO overnight & NO day of RV parking.
2. NO smoking allowed on the grounds.
3. You will not be allowed to leave your vehicle idling in the parking area.
4. There will be a door monitor, you may not enter the building on your own.
5. When entering the building you will enter through the front door and exit through the back door.
6. Once you exit the ring you will need to exit the building.
7. You may not be allowed to watch from inside the building.
8. Check - in will be done outside the building.
9. Crating – there will be **NO** crating in the building. You will be required to crate from your vehicle. Bring canopies and/or shade cloth. Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not working. **Note:** farm animals and cats on property. Air your dog on Gravel driveway. Do not air on grass, plants, barn or equipment. **Note:** water is well water and safe to drink.
10. **Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Covid 19 – best practices:

1. Participants are required to follow state, local and facility guidelines that are in effect at the time of the event.
2. You will be required to wear a mask while in the building. You may not enter the building if you are not wearing a mask, which means you will be required to wear a mask in the ring while competing with your dog. You must bring your own mask!
3. For parking – leave at least a vehicle or two space between your vehicles. There is plenty of parking.
4. Practice social distancing consistent with current guidelines. Avoid congregating to the extent possible.
5. Consider wearing masks when in close proximity to others.
6. If you utilize the portable toilet, please wash your hands before and after you enter.
7. Avoid shaking hands or hugging.
8. Avoid touching dogs that are not your responsibility.
9. Avoid common use pens/pencils – bring your own.

ADDITIONAL TRIAL RULES

Every precaution for the safety of dogs and exhibitors will be exercised, but neither the Club nor the management will be responsible for loss or injury.

Exhibitors are asked to refrain from bringing family and friends that are not showing dogs. This is to minimize the number of people on the trial site during the pandemic.

Only dogs that are eligible to be shown under AKC rules shall be allowed within the show precincts.

All dogs must be **ON LEASH** at all times while on show grounds and parking areas unless in the ring for judging.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Consult the judging schedule for the time of judging. Exhibitors and handlers are responsible for the presence of their dogs in the judging ring. The Club assumes no responsibility for this.

CATALOG ORDER: As far as is practical, all entries will be arranged according to jump height, in descending order for all obedience and rally classes that require jumps.

In case of a tie for an award, a dog not present for a run-off will forfeit the right to the award.

Rally Maps will be emailed Thursday, after 6:00PM. No printed maps will be distributed at the trial. Maps will be posted at the site as well.

Print or type entries carefully, using BLACK or BLUE ink. The Club accepts no responsibility for incorrect or illegible entries. Entries that are received unsigned, without the proper entry fee or without both sides of the form, will not be accepted.

No entries can be changed or refunded after the closing date.

Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date, nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances, fire, act of God, act of a public enemy, strikes, extreme weather conditions (including, but not limited to, extreme heat, snowstorms or hurricanes) or any other act beyond the control of the management it is impossible to open or to complete the Trial, no refund of entry fee will be made. **Entries will be refunded only if the trial is cancelled due to Covid19.**

Acknowledgement of receipt of entries will be made soon after closing date. **Confirmations and judging schedule will be emailed only.** Please include your email address on your entry form. Should such acknowledgement not be received by an exhibitor five days prior to the trial, please contact the Trial Secretary.

Move-ups will be allowed at these trials per AKC Regulations.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in

the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
