Members may be required to pay fees upon application, GVEA also requires a separate deposit for each meter, unless a letter can be provided from the utility which last provided comparable service, stating that within the last twelve (12) months of continuous service, the applicant has not been past due in payment more than twice, has not been delinquent in payment in the last six (6) months, and the service must have been provided within the last two years. A deposit may be waived upon application of service for returning member upon satisfaction of these same criteria from the Association's records
