2019 PEPSI STATE FINALS RSVP & TOURNAMENT INFO

For bowlers that have qualified from the District Finals to the State Finals. Please read the tournament rules carefully.

RSVP Window: APRIL 6-14, 2019 • State Finals: MAY 4-5, 2019

STATE FINALS QUALIFIERS: State Finalists (U12, U15, U17 & U20 divisions) will qualify (scratch) from District to State based on a ratio of **1:5** or major fraction thereof, including last place ties per division. ***IT IS THE STATE FINALIST'S RESPONSIBILITY TO CHECK ONLINE AT CALUSBC.COM TO SEE IF THEY QUALIFIED TO THE STATE FINALS. QUALIFIERS MUST REGISTER THEIR SQUAD TIME ONLINE APRIL 6-14 IN ORDER TO BOWL.*** Space is limited and filled on a first come, first serve basis.

FORMAT: \$10 ON-SITE ENTRY FEE. Qualifiers must select one squad, which consists of six (6) games moving pairs after each game. Each division will earn scholarships and one of six berths into the 2019 USBC Junior Gold Championships (DETROIT, MI) if they have not already previously qualified. Champions, scholarships and Junior Gold berths will be determined by total scratch pinfall per division. The California USBC will provide the eight division champions a travel stipend to Detroit valued up to \$400. ***CALIFORNIA ALSO OFFERS AN OPTIONAL HANDICAP SCHOLARSHIP DIVISION (100% OF 210) ON-SITE.***

DIRECTIONS: From the north: 101 South, exit Golf Course Drive (exit 484A) and turn left (east) toward Wilfred Avenue. Continue on Golf Course Drive and then turn right on Fairway Dr. Bowl will be on the right. **From the south:** 5 North to 580 West to 101 N. Exit Commerce Blvd (exit 484A) and turn left. Turn right onto Golf Course Drive and then turn right on Fairway Dr. Bowl will be on the right.

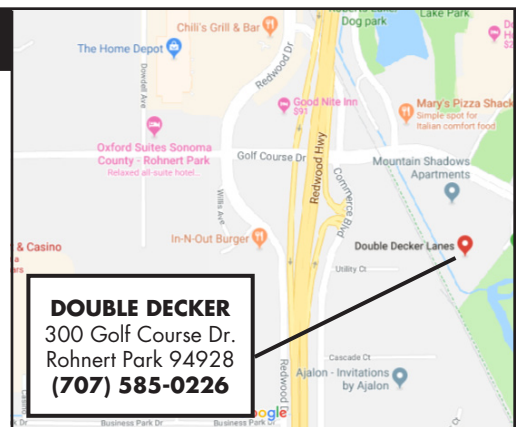

You will be immediately contacted **ONLY** if there is a problem. **MAKE SURE YOUR REGISTRATION PROCESSED CORRECTLY – AN AUTOMATED EMAIL WILL BE SENT TO YOU WITH A SUMMARY OF REGISTRATION.** All registrations will be verified – **OFFICIAL CONFIRMATIONS** will be sent by e-mail. **BRING YOUR E-MAILED CONFIRMATION LETTER (WITH BARCODE) TO THE STATE FINALS FOR CHECK-IN.** If you do not receive your letter by April 30, contact us immediately. Confirmed finalists will be posted online at CalUSBC.com. Contact your coach for help if you don't know the required information. ***E-mail registrations will NOT be accepted.
