Prizes, Ribbons and Awards

All dogs earning a qualifying score will be awarded a qualifying ribbon. As well, in each of Starters, Advanced, Masters and Games rounds, first to fourth place ribbons will be awarded in each height division for Open, Veterans and Specials rounds.

Title ribbons will be awarded for teams that earn the following titles: ADC, SGDC, AADC, AGDC, MAD, MJDC, MSDC, MGDC, MTDC, ATChC, and Lifetime Achievement Award of Excellence. Title ribbons may be purchased at a cost of \$10 for teams earning the following titles: Expert Bronze, Silver and Gold Awards, Bronze, Silver and Gold Award of Merit, and Versatility Bronze, Silver and Gold Awards. A team earning several titles for one run, the first title ribbon will be awarded. Subsequent title ribbons may be purchased at a cost of \$10 regardless if they are listed above.

General Information

Title Trial - Dogs will be divided into 5 height groups in 4 different divisions; Regular, Special, Veteran & Double Drop Veterans. The Masters Standard courses are open to all dogs that have an AADC Title; the Masters Games are open to all dogs that have received three corresponding Advanced Games qualifying scores in the same game under 2 different judges. The Advanced Standard courses are open to all dogs that have an ADC; Advanced Games are for dogs that have received two qualifying score in the same Starters Game under 2 different judges. Starters Standard courses are open to all dogs that have not received their ADC title. Starter Games are open to any dogs that have not received two qualifying scores in that event. Steeplechase is open for any dog entered, Team Relay is open for any dog to enter, however Team courses will be at the Masters Level. AAC Challenge course is open to dogs who have received their AADC or higher only.

Obstacles- Rubberized A-Frame, Dogwalk, Teeter Totter, Weave Poles, Table, Flexible Tunnels, Self-Healing Tire Jump, Ascending Spread Jump, Double Jump, and Single Jumps. LTD Winged Jumps.

Facilities- This is an indoor trial and will be held rain or shine. You will be required to provide your own seating (small bleachers are available in the arena), water (drinking and cooling) and crating for your dog. Come dressed in layers for the weather. Although it is an indoor trial, temperature may change throughout the day. Heated crating area is provided.

Dog Aggression- All dogs **MUST** be kept in an x-pen, crate, in your car, or on leash when not in the ring. This includes the grounds and parking lot. IN ORDER to avoid incidence of dog aggression, please give all dogs lots of room and be aware of what your friendly dog is doing. Any dog engaging in aggressive behaviour at any time will be required to leave the event grounds. In such cases NO refunds will be issued.

Notice to Participants

This trial will be held under AAC rules.

This is a LIMITED entry trial.

Trial will be run on a dirt surface inside and will be run regardless of weather conditions.

Competitors, through submission of entry, acknowledge that they know the AAC rules and regulations.

Handlers should be aware of the running order and watch for possible changes. All dogs must be ready in the ON DECK area at least 2 dogs prior to their run.

Move Ups are permitted and the Trial Secretary must be informed. No collars, toys, treats or other training aids will be permitted on course at any time. Leads are allowed to enter the ring but must be left behind the start line. All obstacles conform to AAC specifications.

This trial is open to all dogs, purebred and non-purebred, that are at least 18 months of age and have an AAC ID number. **ALL DOGS** must have an AAC ID number issued by the AAC prior to the event. Please note it may take several weeks to receive your ID Card. NO ID cards are available for purchase at the trial. A Valid AAC ID card must be presented at the trial check-in; otherwise the dog must be measured for verification of jump height and must jump the height they are measured at.

No Prong or E-collars allowed at the On Target Dog Training facilities.

There will be no refunds for entries withdrawn after the closing date, except for injured dogs or bitches that come into season. There will be no refunds in the event a dog and/or handler are dismissed from competition, regardless the reason. There will be no refunds once the trial has commenced.

Cheques will be deposited once received. No postdated cheques shall be accepted. An NSF fee of \$25.00 will be charged to any returned cheques. Trial confirmations will be sent out; including schedule of events.

PLEASE clean up after your dog. ANYONE seen not cleaning up after their dog will be dismissed from the trial site immediately without refund.

Any handler who is found to be abusive to their dog will be dismissed from the trial and the incident shall be reported to the AAC Disciplinary Committee.

On Target Dog Training organizing committee has reserved the right to refuse any entry, for any reason.

FEO runs will be allowed with NON-AUDIBLE toys in any event

During the COVID-19 Pandemic

Hello everyone! We are trying very hard to offer a safe and enjoyable agility experience. However; it's going to take the cooperation of everyone involved to make this a success. We've implemented a list of rules in order to open. You will see that some things are temporarily changed. If you disagree with any of the new rules please come back when things are back to usual.

COVID RULES:

1. STAY HOME IF YOU ARE FEELING SICK!!!! Here is the link to Ontario's COVID 19 Self-Assessment Tool: <https://covid-19.ontario.ca/self-assessment/> Please take the assessment on the morning of the event.
2. DISINFECT YOUR HANDS REGULARLY. Refrain from touching your face.
3. Follow all Provincial and Municipal guidelines with regard to COVID-19 precautions.
4. Please refrain from touching anything that isn't yours. Stay on guard against touching anything that may have been touched by others. Carry your own hand sanitizer or wipes and USE THEM!
5. Maintain social/physical distance.
6. Please bring your own mask. Provincial guidelines recommend wearing a mask when social distancing cannot be maintained. Please be advised that we will not be providing masks or gloves to competitors.
7. Gloves are an individual choice. Studies show frequent hand washing is better than gloves in most cases. If you do wear gloves be VERY aware of not touching anything else during that time. If you prefer to wear gloves, you will need to bring enough pairs for the times you will need to wear them.
8. Competitors may be accompanied by members of their same household.
9. Please use hand sanitizer when entering the ring to volunteer and again when you leave the ring. Hand sanitizer will be available at the outside of the ring.
10. Bring your own food, snacks, water, drinks, etc..
11. Make sure your dog is ok with people wearing masks. We don't want a dog becoming fearful due to something they've never seen before.

Be respectful to everyone!

Be patient with everyone!

Follow all trial rules and health precautions!

TRIAL PROCEDURES:

- 1) You may set up in your car or in a shade tent. In both cases, be sure to maintain safe social distancing.
- 2) Course maps will be posted so you can take a photo with your phone. Do not crowd the map location. Maps will be posted outside the building and near the ring. (see Kim if this is a problem).
- 3) General briefing will be on Facebook and emailed before the trial.
- 4) JUDGE'S BRIEFINGS: There will not be the usual briefings. The judge will specify a location at the site to answer questions during each walk thru, keeping physical distancing in mind.
- 5) RUNNING ORDERS: Running Orders will be posted in a few locations on the property
- 6) WALK-THROUGHS will be divided into two (2) groups if needed. They will be 7 minutes for a single walk through and 5 minutes each if a divided walk through. **FACE MASKS ARE MANDATORY DURING WALK THROUGHS.**
- 7) GATE STEWARD & CHECK IN: There is no check in at the gate. The Gate Steward will call out during the walk thru to check-in dogs. (**Gate stewards, please try to bring your own pen/marker for check-in.**) As the Gate Steward will not be at the gate, it is the handler's responsibility to be on time and ready for your run. **Be sure to maintain your Physical Distance from everyone in the area!**
- 8) THERE IS NO LEASH RUNNER. Throw your leash along the fence line toward the exit gate. Place it on the table or put it in your pocket. Walk or carry your dog to the start.
- 9) TIMER & SCRIBE: The scribe and timer must sanitize their hands before and after working, and wear masks when appropriate social distancing is not possible. The timer may be asked to wear gloves while operating the timer box. If wearing gloves, please throw them in a waste receptacle immediately upon leaving the ring.
- 10) The entrance and exit gates swing in both directions. They will not be latched. Open and close them with your foot, leg, hip – not with your hands.
- 11) COURSE BUILDERS & RING CREW: Please wear disposable gloves or use hand sanitizer and/or wipes before and after working. If wearing gloves, please throw them in a waste receptacle immediately upon leaving the ring. **FACE MASKS ARE MANDATORY FOR COURSE BUILDERS.** We ask that Ring Crew use their own chairs.
- 12) SMALL BUILDING: For this event, ONLY the Judge, Trial Secretary, and Chairperson have access to the secured area. If you need to speak to any of these individuals, please see them outside at a safe distance. Unfortunately, indoor crating is not available (Above mentioned authorized persons excepted). This building will also house a WASH STATION.
- 13) RESULTS will be posted in the area of the course maps. Again, please do not crowd the area. Take a photo and move on if others are waiting.

- 14) RIBBONS and ROSETTES will not be formally presented at the trial. We are very happy to provide your ribbons though! Please let us know and they will be made available for you. If you are **not** going to keep the ribbons, please do not take any – ribbons cannot be recycled at this time.
- 15) MEASURING rules have been suspended for the 2020 season. Anyone who has one confirmed measurement will be competing at that height until the end of the year and will not require a second measurement at this time. The only dogs that are to be measured are dogs with no measurement on their ID card. This includes dogs under 2 years old. No final measurements will be carried out and no Dog ID cards will be signed. Dogs with one measurement on their card will compete at that height for every trial in 2020, or until the normal measurement process resumes. Dogs with 2 conflicting measurements on their card will compete using the last recorded measurement on the card until the normal measurement process resumes. **If your dog requires measuring, please wear a mask as this procedure may cause you to come in close contact with our judge.**
- 16) REFUND POLICY: If you feel uncomfortable about your personal safety at any time between the time you send your entry and prior to your first run, and wish to withdraw, a full refund of your entry fees will be provided. If the trial must be cancelled due to pandemic related circumstances, a full refund will be provided.

Given the ever-changing nature of the COVID-19 pandemic, we will update this information as necessary.

Again, these are unusual times. So, if you don't agree with any of the above rules please join us again when things change.

- **Waiver of Liability and Informed Consent**

COVID-19 Waiver

Any liability to anyone for any incident involving myself, the location, or those pets or actions of other participants and spectators will be my sole responsibility and I assume all financial liability and will also assume all and any financial costs associated with my actions.

This trial is being held under the Agility Association of Canada, Inc (AAC) Rules and Regulations. Exhibitors, through submission of entry, acknowledge that they understand the AAC Rules and Regulations, including but not limited to the following

Class Descriptions

AAC Starters Class: The Starters class shall be for dogs not having earned the Agility Dog of Canada (ADC) title. A dog must achieve three clear rounds under at least two different judges to be awarded the ADC title.

AAC Advanced Class: The Advanced class shall be for dogs having earned the Agility Dog of Canada (ADC) title, but that have not earned the Advanced Agility Dog of Canada (AADC) title. A dog must achieve three clear rounds under at least two different judges to be awarded the AADC title.

AAC Masters Class: The Masters class shall be for dogs having earned the Advanced Agility Dog of Canada title. To be awarded the Master Agility Dog of Canada (MADC) title, a dog must achieve three clear rounds under at least two different judges.

AAC Veterans Classes: Veterans classes are for dogs seven years of age or older, or dogs five years and older who have been competing in Specials agility class for a minimum of one year.

AAC Specials Classes: Specials classes are open to all dogs. Handlers running a dog in Specials will have the option to move into Regular classes once during the dog's career. A switch from Specials to Regular cannot be made mid-trial. Dogs moving into Veterans or Specials from Regular classes take their titles with them.

Games Classes: Games classes are offered to Starters, Advanced and Masters dogs. Progression from one level to the next is as follows:

- Movement into an Advanced Game from a Starters Game requires two qualifying scores in that game at the Starters level earned under two different judges (or completion of one qualifying score in that game prior to January 1, 2009).
- Movement into a Masters game from an Advanced Game requires three qualifying scores in the game or, if earned prior to January 1, 2009, two qualifying scores in the game at the Advanced level under two different judges.

AAC Steeplechase Class: Steeplechase is open to dogs competing at all levels (Starters, Advanced and Masters).

AAC Challenge Class: Challenge is open only to dogs who have completed an AADC and are therefore eligible for Masters Standard courses.
