1. The Metro New Jersey Chapter of the Appraisal Institute (“Chapter”) reserves the right to terminate this agreement at any time and for any purpose upon notice.
2. The Metro New Jersey Chapter’s liability for any error or omission shall not exceed the annual sponsor fee. The Chapter assumes no liability, if for any reason it becomes necessary to reject the Sponsor or to terminate this sponsorship agreement.
3. For any of Sponsor’s communications, advertisements or promotions that is in relation or in regards to the chapter sponsorship or the Chapter, the Sponsor agrees to provide the Metro New Jersey Chapter the right to approve, revise and reject any of those communications, advertisements or promotions. If the Sponsor fails to abide by this provision, this Sponsorship Agreement may be terminated immediately by the Metro New Jersey Chapter.
4. The Sponsor shall provide the Chapter with a company logo to allow the Chapter to acknowledge or give recognition to the chapter sponsorship in e-mails, newsletters or on the website or conference signage.
5. If the Sponsor attends a chapter conference, prospecting or solicitation shall not be allowed without the prior approval of the Metro New Jersey Chapter.
