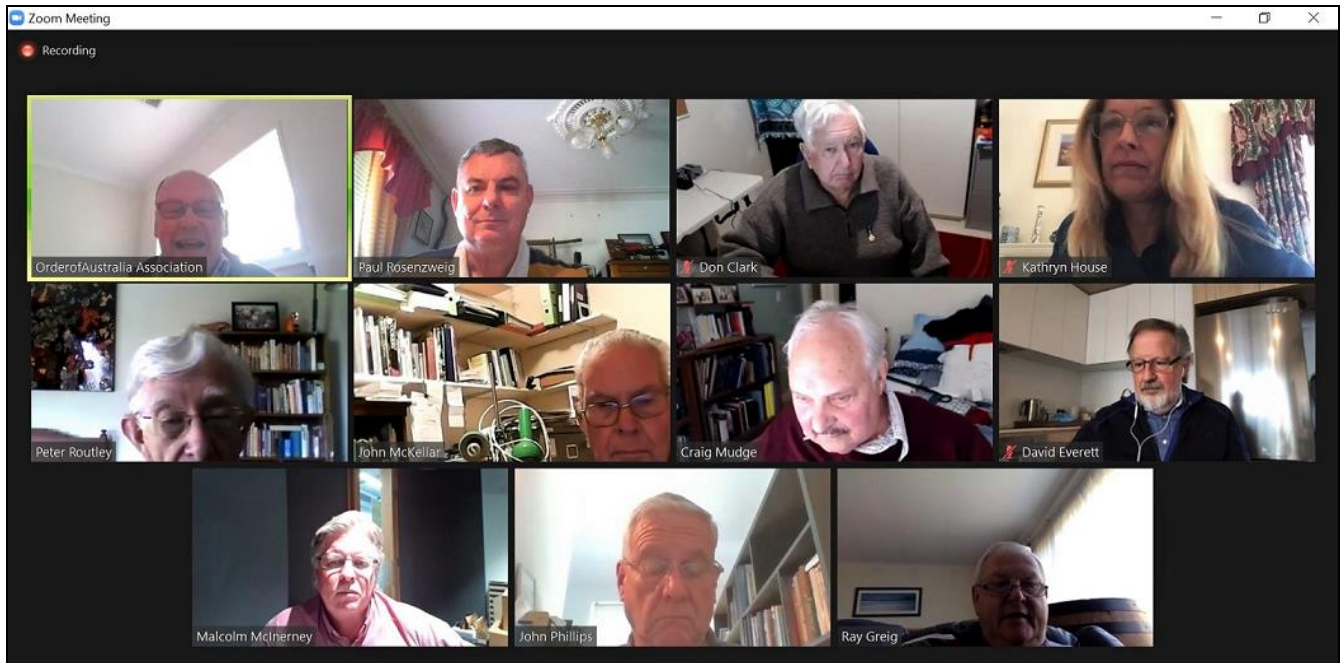

### CITIZENSHIP RESOURCE VOLUNTEERS

The SA Branch committee is considering a new initiative to engage with our younger community members in a meaningful way – through the creation of Citizenship Resource Volunteers.

These volunteers will visit secondary schools to support teachers in delivering a prepared classroom lesson on the Australian National Honours system and the ways in which individuals may contribute to civic life and serve others.

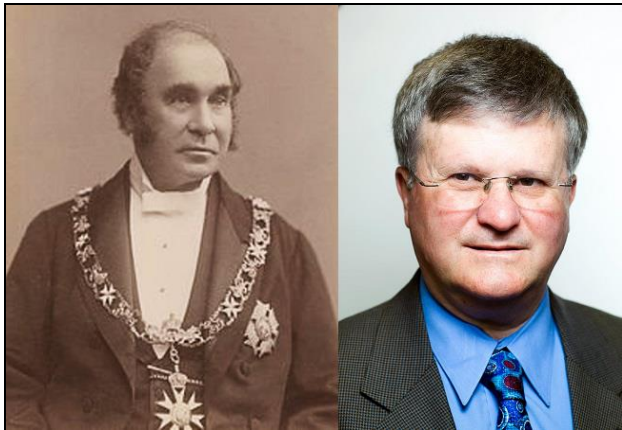
On 23 September, the first induction session was delivered online via Zoom. Ten participants joined in the session, facilitated by Noel Hender OAM BEM.

Malcolm McInerney (Department for Education), a subject matter expert in Humanities education and current Manager of the Governor's Civics Awards for Schools, gave an overview of the Citizenship Knowledge and Understanding Strand, Civics and Citizenship from the Australian Curriculum for Schools.

Paul Rosenzweig OAM provided an overview of the Australian Honours System and the Order of Australia. Noel provided details regarding the management of the process.

Some of these volunteers will take part in an initial pilot program in schools to test the program's feasibility.

Among them was the 2014 South Australian Scientist of the Year, Professor Anthony Thomas AC who is the seventh Elder Professor of Physics at Adelaide University, a position funded by Sir Thomas Elder.

We are now able to connect and involve members across the state and to facilitate any members wishing to be guest speakers by zooming their talk and presentation from their homes.

### THE ORDER OF AUSTRALIA

#### Did you know...?

When the Order of Australia was originally created, it comprised just three grades, Companion, Officer and Member – there was no provision for a knighthood, nor was there a Medal associated with the Order (such as the British Empire Medal associated with the Order of the British Empire).

The Order of Australia was created by Her Majesty Queen Elizabeth II, Queen of Australia, on the advice of the Prime Minister of Australia, by Letters Patent given under the Great Seal of Australia at St James's on 14 February 1975.

In these Letters Patent, published in the *Australian Government Gazette* No S28 of 17 February 1975, the Order was created in three grades: Companion (AC), Officer (AO) and Member (AM).

These appointments could be made in either the Civil Division or the Military Division (the former was retitled 'General Division' in 1976).

On 24 May 1976, the Medal of the Order of Australia (OAM) was created by the Queen on the advice of the Australian Prime Minister.

At the same time, the levels of Knight (AK) and Dame (AD) were also created. Of note, the level of Knight/Dame could be awarded only in the General Division.

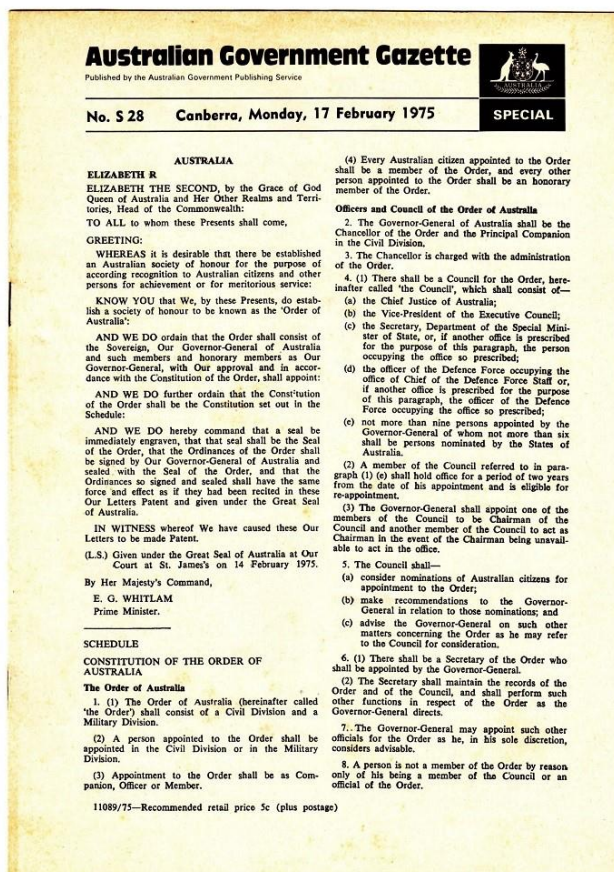
Following the 1983 federal election, on the recommendation of the Australian Prime Minister, the Queen co-signed Letters Patent dated 3 March 1986 directing that no further awards were to be made at the level of Knight or Dame.

Existing Knights and Dames were not affected by the change. By that time, twelve Knights and two Dames had been created (all but one are now deceased).

This level was re-introduced by Letters Patent dated 19 March 2014, to recognise "*Extraordinary and pre-eminent achievement and merit of the highest degree in service to Australia or to humanity at large*".

Three appointments as Knight were made, and two as Dame.

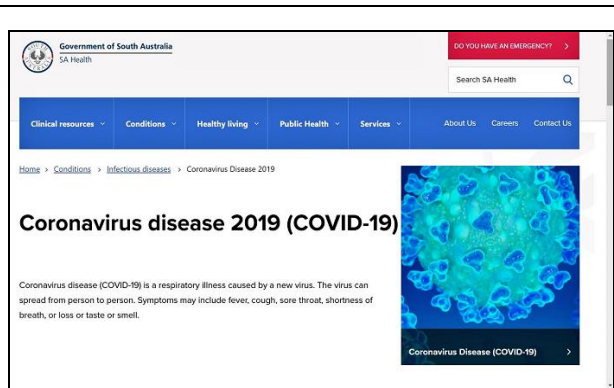
Since 2015, the Knight/Dame level has again been discontinued (amendments to the constitution of the Order were gazetted on 22 December 2015).



### The creation of the Order of Australia

The Letters Patent for the Order of Australia, given under the Great Seal of Australia at St James's on 14 February 1975, were published in the *Australian Government Gazette* No S28 dated 17 February 1975.

### **SOUTH AUSTRALIA BRANCH: COVIDSafe**

The SA Branch committee has been working hard these last several months to ensure compliance with national and state government COVID-19 directions.

This is a summary of how we have proven ourselves to be COVIDSafe in our 'workplace'.

The Branch committee has used transformational management principles to ensure compliance and innovation while continuing to deliver services to our members and posturing ourselves for the future.

In March, we reduced the risk of disease transmission by immediately ceasing all face-to-face activities and cancelling upcoming events.

Committee functions however, continued via monthly 'virtual' meetings using 'Zoom'.

We modified our business procedures to keep our members engaged. Previously, quarterly newsletters focussed on upcoming events; from March, we switched the focus to general interest stories and positive messaging – see here:

With Anzac events cancelled, we encouraged members to pay their respects through reverent reflection at home.

Our Fellowship group had previously met each second month for lunch with a guest speaker. For the 30 April meeting, the Fellowship coordinators instead used Zoom to host a 'virtual meeting' accompanied by a PowerPoint presentation: the speaker was joined by 21 online participants.

With the easing of restrictions, the Fellowship Group next met at the Naval, Military and Air Force Club on 25 June – with 12 lunch guests *and* ten online guests using 'Zoom'.

To mitigate infection risks, lunch guests followed distancing and density guidelines and hygiene controls. The speaker gave his presentation online, also projected onto the 'big screen' for the lunch guests.

These changes to our business model have seen a generational change, with technology being embraced and proven to be an effective means of service delivery.

Holding future meetings via 'Zoom' will allow country members to be more involved in branch operations and let them serve as committee members. The Fellowship lunch meetings also using a Zoom subscription will allow for greater participation by regional members.

Despite the financial impost, the committee has been "performing whilst transforming", and this evolution has led us to realise there is no limit to serving our membership.

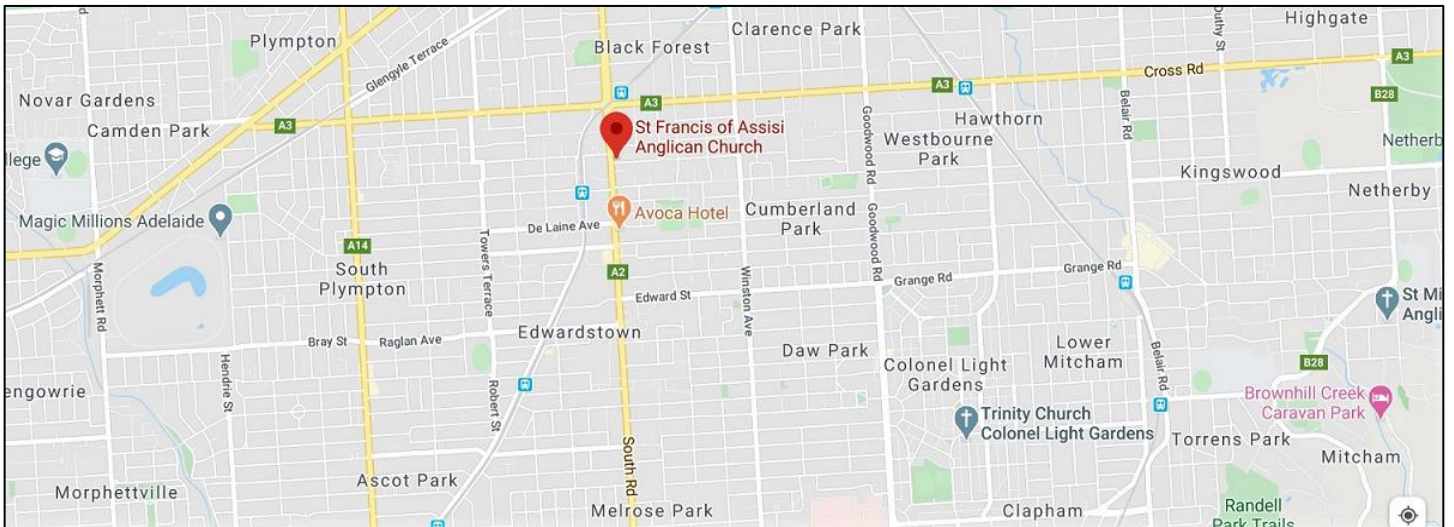
