# **Engineer's Report**

## Jim & Nena's Land Development Status

Engineer Knouse reported to Council that following an inspection for the Jim & Nena's Land Development Plan, there were fifteen (15) outstanding items that needed to be addressed. In response, the developer has submitted a revised land development "as built" plan, dated November 15, 2010. On the plan, the developer is seeking modifications from the following original approved plan: 1. Removal of handicap ramp, providing access from sidewalk along Hanover Street into the site. 2. Removal of pedestrian access through the parking-lot island and relocating the position of island. 3. Removal of a landscaped area at the eastern end of the building and replacement with paved area. 4. Removal of landscaped area at the western side of the building and replacement with paved area. 5. Addition of concrete pad to the east along the rear parking lot for a proposed generator. 6. Large tree at the rear of the property was not removed, the modified plan calls for additional grading to manage stormwater runoff. It was pointed out that the following deficiencies are to be corrected in accordance with the inspection report: 1. The plan should clearly indicate the flood zone boundary. 2. The plan does not address the trees that were eliminated as a result of the modifications. 3. The plan does not address the relocated position of the handicap spaces. 4. The plan does not address the improper striping of the parking spaces. 5. The proposed generator and generator pad are not in conformance with the Borough's Floodplain Management Ordinance. 6. The plan shall include reference to the approved plan and appropriate recording information. William T. Gentzler made a motion, seconded by Samuel H. Spagnola, to approve the revised "as built " plan for the Jim & Nena's Land Development plan with the comments as noted by Engineer Knouse's letter dated December 21, 2010 and eliminating the need to have the revised plan recorded in the office of the York County Recorder of Deeds. Motion carried with a nay vote noted by Michael H. Altland.

### 2011 Office Roof Replacement

Engineer Knouse and Manager Shaffer requested direction from Council regarding the budgeted project for the roof replacement at the Borough office. It is Council's desire to have the work done in the spring. Solicitor Jones brought to Council's attention that there are cooperative purchasing programs available that some of the area school districts have used in order to avoid having to go through the bidding process. Engineer Knouse agreed to work with Manager Shaffer to see if that opportunity is available to the Borough.

## 2010 Sewer Rehabilitation Project Update

Engineer Matt Warfel reported to Council that the final punch list items have been completed. After reviewing the post installation lateral videos, where they reviewed the entire inside of the sewer line and compared that to the pay application, it was determined that the sub contractor overbilled for six (6) additional laterals for a total cost of \$47,428.45, which the Borough will be receiving as a credit change order.
