Motion by Ernie Schiller, second by Steve Burgmeier to approve assessing Argyle residents' on their RUSS sewer bill for the fee payment to obtain the water usage report, and in future this additional fee should be included in the coupon booklets. Motion carried.

#### SRF P&D LOAN EXTENSION - SELMA

# GEODE RC&D AGREEMENT

Motion by Kent White, second by Steve Burgmeier to approve the contract with Geode RC&D as discussed, at \$1,000 per month and \$37.50 per hour per person, for a period of 90 days after review by RUSS attorney and with the option to extend or cancel the contract by consent of both parties. Motion carried.

# EASEMENT ACQUISITION - OLLIE
