

It is against the law for the Mid-Maryland Workforce Development Area's Carroll County Business & Employment Resource Center (BERC) and the Howard County Office of Workforce Development (HCOWD), as recipients of federal financial assistance, to discriminate on the following basis: against any individual in the United States, on the basis of race, color, religion, sex, national origin, age, disability, political affiliation or belief; and against any beneficiary of programs financially assisted under Title I of the Workforce Innovation and Opportunity Act (WIOA), on the basis of the beneficiary's citizenship/status as a lawfully admitted immigrant authorized to work in the United States, or his or her participation in any WIOA Title I-financially assisted program or activity.

The Mid-Maryland Workforce Development Area must not discriminate in any of the following ways: deciding who will be admitted, or have access, to any WIOA Title I-financially assisted program or activity; providing opportunities in, or treating any person with regard to, such a program or activity; or making employment decisions in the administration of, or in connection with, such a program or activity.

If you think you have been subjected to discrimination under a WIOA Title I-financially assisted program or activity, you may file a complaint within 180 days from the date of the alleged violation with either Heather Powell, the Equal Opportunity (EO) Officer for the Mid-Maryland Workforce Development Area, located at BERC, 224 N. Center Street, Westminster, MD 21157; or the Director, Civil Rights Center (CRC), U.S. Department of Labor (DOL), 200 Constitution Avenue NW, Room N-4123, Washington, DC 20210.

If you file your complaint with the EO Officer, you must wait either until the EO Officer issues a written Notice of Final Action, or until 90 days have passed (whichever is sooner), before filing with the Civil Rights Center (see address above). If the EO Officer does not give you a written Notice of Final Action within 90 days of the date on which you filed your complaint, you do not have to wait for the EO Officer to issue that Notice before filing a complaint with CRC. However, you must file your CRC complaint within 30 days of the 90-day deadline (in other words, within 120 days after the date on which you filed your complaint with the EO Officer).

If the EO Officer does give you a written Notice of Final Action on your complaint, but you are dissatisfied with the decision or resolution, you may file a complaint with the CRC. You must file your CRC complaint within 30 days of the date on which you received the Notice of Final Action.
