NOTICE IS HEREBY GIVEN that Early Voting for the March 17, 2020 General Primary Election will commence on Thursday, February 6th at the County Clerk's Office, and conclude on Friday February 28th. Hours for Early Voting at the County Clerk's Office will be Monday through Friday 9:00 a.m. to 5:00 p.m. Early Voting will extend to the additional **sixteen** sites in Lake County on Monday, March 2nd and end on Saturday, March 14th. During the week of March 2nd and March 9th, hours for Early Voting for all Lake County voters are Monday through Friday from 9:00 a.m. to 5:00 p.m. and Saturday from 9:00 a.m. to 2:00 p.m. The four State Mandated Early Voting sites will remain open Sunday, March 8th from 10:00 a.m. to 4:00 p.m. During the week of March 9th, the four State Mandated Early Voting sites will extend their hours to Monday through Friday until 7:00 p.m., Saturday and Sunday from 9:00 a.m. to 4:00 p.m., and they will remain open on Monday, March 16th from 9:00 a.m. to 7:00 p.m.

Grace Period Registration and voting will be offered at all Early Voting locations.
