# **ENTRY FORM**

Entry to this Championship confirms acceptance of the entry declaration:

**Entry Declaration:**

On behalf of our National Squash Association, I hereby confirm our entry to participate in the 26<sup>th</sup> WSF Men's World Team Squash Championship and declare:

1. that our National Association is a Full Member of the World Squash Federation (WSF) and is eligible to participate in this Championship; and that all our players will be eligible to represent our country, which may be verified in accordance with the Regulations;
2. that we are aware of the WSF World Championship Regulations that govern this Championship and hereby agree to abide by all such regulations;
3. that our team shall participate at their own risk and not hold the organisers, the sponsors, the host association or the WSF responsible for any injury, disability or death arising from such participation;
4. that we, our team management and squad understand that anti-doping tests may be carried out on any or all players at any time from arrival until departure and all accept and undertake to abide by the current WSF Anti-Doping Rules, and that I, as a member of my WSF Member Nation and/or a participant in a WSF, PSA or WSF Member Nation's authorised or recognised event, hereby declare as follows:
  - a) that I shall comply with and be bound by all of the provisions of the WSF Anti-Doping Rules, including but not limited to, all amendments to the Anti-Doping Rules and all International Standards as issued by the World Anti-Doping Agency and permanently published on its website.
  - b) I acknowledge that PSA, WSF Member Nations and National Anti-Doping Organisations have jurisdiction to impose sanctions as provided in the WSF Anti-Doping Rules
  - c) I also acknowledge and agree that any dispute arising out of a decision made pursuant to the WSF Anti-Doping Rules, after exhaustion of the process expressly provided for in the WSF Anti-Doping Rules, may be appealed exclusively as provided in Article 13 of the WSF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
  - d) I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
  - e) I have read and understood this declaration
5. that all squad members and designated team officials must have an active SPIN in order to participate.
6. that WSF certified protective eyewear must be properly worn at all times when on court by all players aged under 19.

## **Entry Details:**

1. The total entry fee for a squad of four male players and the appointed manager and coach is **£4450.00**.
2. The entry fee covers accommodation in a maximum of 3 twin rooms for the nights of 14 December – 21 December 2019 inclusive (8 nights). The cost of breakfast is included in the entry fee but the cost of all other meals is the responsibility of the entrant.
3. The entry deadline is **16 June 2019 – 23:59 GMT** - no late entries will be accepted.
4. An invoice for the full entry fee will be raised as soon as your on-line entry is received. The full entry fee must be remitted by **16 July 2019**.
5. If the entry fee and WSF membership Fee for 2019 is not paid by the 16 July deadline, then your entry will be **automatically cancelled**
