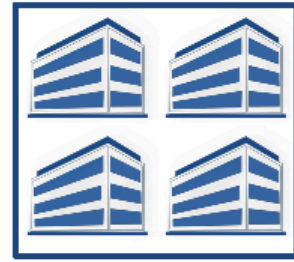

Single Unit

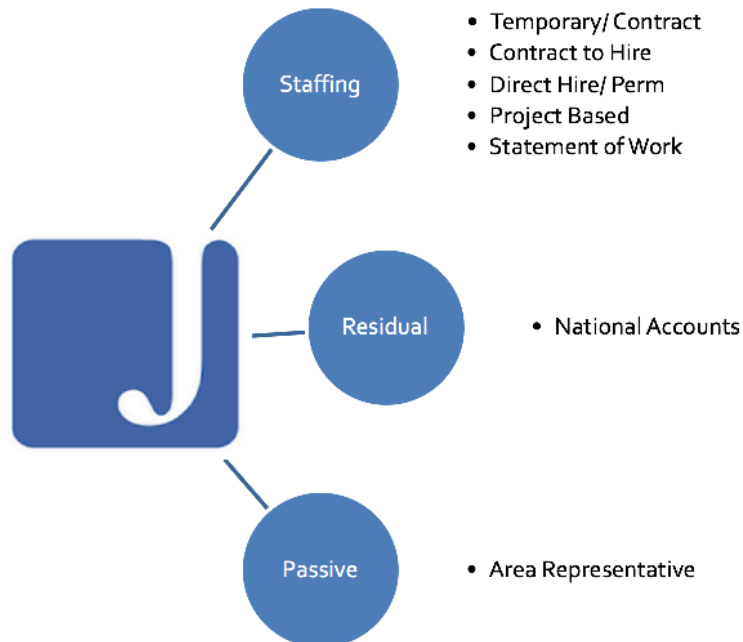


Multi Unit
