Terms & Conditions

Clients Representations & Obligations

(1) There is good access to the performance area (e.g. paved sidewalk or walkway, NO stairs, reasonable areas of ingress and egress). An exception requires an inspection and prior approval of the performance area by a Platinum Flash Photo Booth employee; (2) There is a 120v electric outlet within 10 feet of the desired area; (3) If the event is outdoors, there must be level and concrete like surface for the placement of the photo booth or equipment; (4) NO food or drinks allowed in booth, client shall be responsible for damage to the photo booth caused by the client or any of the client's guests; and (6) If the event is outdoor and weather conditions do not allow for booth to be outside client must provide sufficient shelter or cover for the photo booth equipment.

Platinum Flash Photo Booth, LLC Representations & Obligations

(1) Transport and provide an operational photo booth for the duration of the number of hours booked on reservation. Client acknowledges the photo booth may require onsite maintenance and/or servicing during the event, and consequently the photo booth may only operate for 90% of the duration of the number of hours booked as a result maintenance or servicing that may be required; (2) Provide a qualified and experienced Platinum Flash Photo Booth Employee to maintenance and service the photo booth as required; (3) Set-up and break down the photo booth in a timely manner.

Other Terms & Conditions:

1. A \$300.00 deposit is required to reserve an event date. Balances are due at least 10 days prior to the event. If the balance is not paid ten days prior to the event date, the deposit may be forfeited. **Promotional packages must be paid in full at the time of reserving.** Minimum 30 days cancellation notice needed for a deposit refund (\$50 refund transaction fee applies). **All credit card transactions are subject to a 3% transaction fee (non refundable).**

2. Client and Platinum Flash Photo Booth agree that in the event of mechanical failure, or for any other reason Platinum Flash Photo Booth is unable to provide a functioning photo booth pursuant to this agreement, Platinum Flash Photo Booth's maximum liability is the return of any payments received. If Platinum Flash Photo Booth is only able to provide partial services for any reason, then charges to the Client shall be prorated subject to the 90% clause above.

3. If Client chooses to provide their own photo guest book there is a \$50 fee attached for construction; (a) if event venue has stairs client is subject to a \$200 fee; (b) Damaged or stolen props are subject to a \$25 fee. (c) Client credit card must be on file at the time of reserving for any charges incurred.

4. This agreement sets forth the entire understanding of the Parties with the respect to the subject matter hereof, and no amendment, change or modifications shall be effective unless in writing and signed by both parties hereto. Accordingly, this agreement supersedes all prior oral written and other agreements between parties.
