### Describe why you are selecting Comprehensive Distance Learning as the school’s Instructional Model for the effective dates of this plan.

We are selecting Comprehensive Distance Learning as our Instructional Model because that is our normal operating model. SHAPA has always been a full virtual school and will continue to run in that manner during the 2020-2021 school year. We had no interruption to services when brick and mortar schools closed at the end of the 2019-2020 school year.

**Academic Conditions** – SHAPA will provide at least two virtual orientation sessions for students and families. One will be for all families. The second will be a Freshmen Orientation for incoming high school students. We will have synchronous learning opportunities available to all students every day. The synchronous sessions will be developed into a weekly calendar to maximize student participation and to prevent overlapping. Students will have an opportunity to meet with a variety of teachers throughout the week. Additionally, synchronous special education services will be provided by the Sheridan School District. Daily student contact will be required for attendance purposes. Actual instructional time will follow the recommendations of ODE as outlined in Comprehensive Distance Learning. The duties of the teacher and the duties of the parent will be clearly defined to ensure students receive the supports they need. Every teacher will maintain virtual “office hours” to be available to families. Our grading policies are already clearly defined in our Student Handbook and will remain unchanged. The policies were developed specifically for our online learning environment. We will continue to use formative assessments throughout the school year to inform instructional decision-making.

**Operational Conditions** – Nutritional services are provided by our sponsoring district. Our school does not have the facilities to provide meals to students. Attendance will be recorded daily based on two-way contact with each student. We will continue to offer NHS (our only “club”) to eligible students.

**Student and Family Support** – SHAPA complies with all FERPA regulations. We accommodate TAG students through accelerated learning opportunities and appropriate grade-level content. Online language development is provided by our ELL teacher. The mental, social, and emotional health of our students is monitored by all staff members. We offer daily opportunities for students to make connections. We already have, and will maintain, a comprehensive school counseling program with resources for students at all grade levels and their families. We will develop more refined routines to ensure stability for our students. Through the school year, we will continue to have virtual home visits with our families. We require a minimum of six visits per year. Our policies allow our staff members to use any means available to communicate with students and families. We typically adopt the means with which each family is most comfortable. Additionally, we send out a weekly newsletter to families. We regularly collect feedback from families about their experiences with our school.

**Digital Learning Needs** – To keep our students secure in the online environment, we have adopted the use of Chromebooks which are easily managed at the school level. We can block sites, see student browsing history, and monitor real-time use for each individual. We provide a Chromebook (or similar laptop) to any student who needs one. Families are eligible for internet reimbursement. We also inform families about other internet options available in their neighborhoods. We provide a laptop and cell phone (with a hotspot) for every staff member. All technology is configured and monitored by our Director of Technology. Our Learning Management System is Canvas. All educators receive annual training at a minimum. Monthly training updates are also provided. Canvas ensures a secure platform for our students. Our online content provider is Edgenuity. We update our courses annually to ensure students receive the appropriate instruction and support in each course. We provide monthly, required professional learning for our staff.

We will not return to a Hybrid Learning Model or an On-Site Learning Model. We will remain virtual only for the entire school year.

<input type="checkbox"/> Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. <ul style="list-style-type: none"> <li>• Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the <b>Ready Schools, Safe Learners</b> guidance) and sent home as soon as possible.</li> <li>• They must remain home until 72 hours after fever is gone (without use of fever reducing medicine) and other symptoms are improving.</li> </ul> <input type="checkbox"/> Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19 within the preceding 14 calendar days. <input type="checkbox"/> Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school.
