Conflicts: Due to RVC programming, Holidays, or inclement weather (club closing early) PCT could be bumped. Please note you will only be billed for your number of weeks of PCT will be available. Due to club closed or RVC programming, PCT will not fall on these dates:

- Labor Day
- Halloween
- Thanksgiving Weekend (Thursday – Sunday)
- Christmas Eve (afternoon/evening only)
- Christmas Day
- New Year’s Eve (afternoon/evening only)
- New Year’s Day
- Easter Sunday

- A player, PCT manager, will oversee payment for the whole contract, submitting names, and controlling the members and nonmembers that could sub in the PCT. Singles up to 5 players may be listed, doubles up to 8 players. All players listed must be tennis members or RVC members.
- Any RVC or TENNIS member may sub in PCT for free.
- NONMEMBERS may not play in PCT. Nonmembers cannot be listed as the permanent players in PCT contract.
- PCT may not be rescheduled. However, if an RVC program or closure bumps you, you will be able to reschedule your time in the future. This may or may not be the same time as the original PCT.
- PCT are half year or full year and DO NOT roll over to the next year. A new PCT contract must be submitted each year.
- If multiple groups, select the same PCT a lottery will happen as we have limited court time available.
- PCT manager/groups may reserve multiple courts.
- There are no refunds after PCT has started.

- PCT Manager and Participants must have current memberships throughout the contracted season.
