Changes in Leaf and Yard Debris Collection. *If you stay abreast of all the exciting news in waste disposal, you already may know that the City of Houston has changed the rules regarding collection of leaves and lawn debris. Our lovely Recycling Chairperson, Sherryl Gorman, has investigated the new rules, and reports her findings for us, below.*

The New Compostable Bag Program

In an effort to save taxpayers substantial money and keep “compost-able” yard waste from needlessly filling up costly landfills, the City of Houston will soon begin requiring the use of biodegradable bags for such waste. **Starting April 5**, City of Houston Solid Waste Management Department crews will only pick up bagged yard trimmings placed at the curb in **City-approved compostable bags**. Yard trimmings placed in the garbage cart, or in any other type of container or bag will not be collected. And, if you continue to place yard trimmings in non-compostable bags **you can be fined at a minimum of \$50 and no more than \$2,000!**

Approved compostable bags are available at numerous retailers throughout the city. These bags can be identified by a **logo on the box** specifying “**City Approved**”, and “**City of Houston Biodegradable / Compostable Bag.**” Currently, the following retailers sell these bags:

By diverting this organic material from area landfills, the City anticipates saving at least **\$1.5 million** annually while preserving the environment and valuable landfill space. The Solid Waste Management Department will use avoided landfill costs to add more Houstonians to the Automated Recycling Program


The City of Houston reminds residents that they can “**let it lay or take it away.**” In other words, Houstonians can choose the free alternative to bagging their leaves and lawn clippings by using a mulching mower for “**grasscycling**” or by creating their own personal compost pile. ♣

Weekly household trash pick up on Mondays. NOTE: Recycling is now **every other Monday**, on highlighted days in boxes. Please have your bins out on the curb by 7 am and in by 10 pm.

“Tree Waste” is defined as “clean wood waste such as tree limbs, branches, and stumps (lumber, furniture, and treated wood will NOT be accepted.)”

“Junk Waste” is defined as “items such as furniture, appliances, and other bulky material.”

In light of recent security compromises in our area, here are some suggestions I have researched for helping us all to stay safe.

Our **mail carrier** has these strong recommendations:

1. **Never place a vacation hold online.** Always use the yellow cards that are available at the post office.
2. **Never leave outgoing mail (especially when mailing checks) – or the hold card – where it can be seen.** If you have a locking box, place it inside and a note for the carrier that there is outgoing mail. If you don't have a locking box, talk to your carrier about the best way to notify him/her of a vacation hold; the best thing for outgoing checks is to take them to the post office and drop them in the box there – preferably inside.
3. **Get to know your mail carrier.** Make sure he/she is familiar with your habits. Then if something 'different' happens, it raises a red flag for the carrier who can then ask you about it.

If you are targeted for **credit card fraud** (as happened recently in our neighborhood), **contact the credit card company immediately.** The company should be told that they have issued a fraudulent credit card. In addition, **contact the 3 credit reporting companies – Experian, Transunion and Equifax.*** Everyone with a credit report is legally entitled to a free report every year. By having it, you can find out if there is some credit misinformation that you might not know about. At the same time, you can let these companies know about anything that has happened recently (like the false credit card) that they might not know about.

Here are a couple of suggestions for when you are out and about.

1. **When locking your car in public, do not use the remote device** to lock it. Use the inside button. Someone has come up with a scanning device that reads the remote signals when you use it to lock your car. You lock your car, walk away and return to find it has been burglarized with no sign of break-in. Lock with the button, close the door and when you return, use the remote to enter the car.
2. Another scanner being used in public is a small, **hand-held device that can actually scan the credit cards in your purse or pocket remotely** – for instance, while walking behind you in the airport or grocery store. It also will scan the information in your passport (the new passports contain a computer chip that the old ones did not). One way to fight this is to **use a reflective metal sleeve** to carry these items. They are available for sale, but **aluminum foil** works well too if you prefer to create your own.

It's too bad these precautions have become necessary, but if we are careful, maybe we can put a crimp in a thief's 'best laid plans.'

The 2010 Census; What to Tell and to Whom

The time is approaching when you may find someone at your door claiming to be a US Government Census worker. How do you know if they are legitimate, and how much should you tell them?

The BBB advises us to be cooperative but cautious to avoid becoming victims of identity theft. Here are some guidelines to follow:

If a real **U.S. Census worker** knocks on your door, they will have a **badge**, a **handheld device**, a **Census Bureau canvas bag**, and a **confidentiality notice**. Ask to see their identification and their badge before answering their questions. However, you should never invite anyone you don't know into your home.

Census workers are currently only knocking on doors to verify address information. **Do not give your Social Security number, credit card or banking information** to anyone, even if they claim they need it for the census.

The Census Bureau will not ask for Social Security, bank account, or credit card numbers, nor will employees solicit donations. Any one asking for that information is NOT with the Census Bureau. And, the Census Bureau has decided not to work with ACORN on gathering this information, so **NO ACORN worker should approach you saying he is with the Census Bureau.**

Census workers may contact you by telephone, mail, or in person at home. However, the **Census Bureau will not contact you by Email**, so be on the lookout for Email scams impersonating the Census. Never click on a link or open any attachments in an Email that pretends to come from the U.S. Census Bureau.

Remember, no matter what they ask, you really **only need to tell them how many people live at your address**. While the Census Bureau might ask for basic financial information, such as a salary range, **YOU DON'T HAVE TO ANSWER ANYTHING AT ALL ABOUT YOUR FINANCIAL SITUATION.**

NOTE: If you mailed back the questionnaire sent in March, no Census worker should visit you at all!

More Thoughts on Your Security

Unfortunately, it seems WLP is a target for thieves, with several break-ins since our last newsletter. So far, our residents have suffered no personal injury, thankfully, and we hope no one will. We urge you to take every precaution to protect yourself and your home from crime.

If you see something fishy, **Jo Cook** suggests using **your cell phone to snap a photo**, **if** you can stay safely in your locked car to do so. If you witness suspicious activity, or if you suffer a crime in WLP, please notify our crime alert system immediately at:
